ERRATA ORDER

BY THE COMMISSION: On January 31, 2023, the Commission issued an Order Granting Certificate of Public Convenience and Necessity with Conditions in the above-captioned docket (January 31 Order). It has come to the attention of the Commission that the certificate itself was not attached to the January 31 Order and that some language was erroneously included in the January 31 Order that should be removed and/or replaced.

The Commission finds good cause to amend the January 31 Order in the following ways:

1. In the fourth paragraph under “Evidence and Conclusions for Finding of Fact No. 7,” the last two sentences should be removed. The paragraph should now read as follows:

Considering the foregoing, the Commission concludes that Sumac has complied with the NCEPA and that the Act does not prohibit or impede issuance of the certificate of authority.

2. In the sixteenth paragraph under “Evidence and Conclusions for Findings of Fact Nos. 8-14, the following sentence should be removed: “As testified by American Beech witness Rubin, the Applicant has explored opportunities for offtake from the Facility, including responding to a DENC request for proposals as well and engaging in conversation with potential corporate buyers, and corporate purchases of energy and renewable energy credits from solar facilities in the southeast marked of PJM are projected to increase over the next few years.” The sentence should be replaced with the following sentence: As testified by Sumac witness Robichaud, the Applicant has explored opportunities for offtake from the Facility and may take advantage of several offtake opportunities in the PJM market, and anticipates robust long-term offtake prospects for renewable energy, renewable energy credits, and ancillary services.

3. The Certificate of Public Convenience and Necessity attached hereto is granted to the Applicant, Sumac Solar, LLC.

IT IS, THEREFORE, SO ORDERED.
