BY THE COMMISSION: On November 29, 2021, Blackburn Solar, LLC (Applicant) filed an application (Application) seeking a certificate of public convenience and necessity pursuant to N.C. Gen. Stat. § 62-110.1(a) for construction of a 58-MWAC solar photovoltaic generating facility to be located at 5256 Hickory Lincolnton Highway, Lincolnton, Catawba County, North Carolina. The Applicant plans to sell the electricity generated by this facility to Duke Energy Carolinas, LLC (DEC).

Also on November 29, 2021, the Applicant filed a registration statement for a new renewable energy facility. The registration statement included certified attestations that: (1) the facility is in substantial compliance with all federal and state laws, regulations, and rules for the protection of the environment and conservation of natural resources; (2) the facility will be operated as a new renewable energy facility; (3) the Applicant will not remarket or otherwise resell any renewable energy certificates sold to an electric power supplier to comply with N.C.G.S § 62-133.8; and (4) the Applicant will consent to the auditing of its books and records by the Public Staff insofar as those records relate to transactions with North Carolina electric power suppliers.

On December 9, 2021, the Commission issued an Order Requiring Publication of Notice.

On December 15, 2021, the Applicant filed a verified certificate of service stating that the application and the related public notice were provided to DEC on December 13, 2021.

On January 18, 2022, the Applicant filed an affidavit of publication from the Hickory Daily Record stating that the publication of notice was completed on January 5, 2022. No complaints have been received.

On February 10 and 14, 2022, the State Clearinghouse filed comments. Because of the nature of the comments, the cover letter indicated that no further State

Clearinghouse review action by the Commission was required for compliance with the North Carolina Environmental Policy Act.

The Public Staff presented this matter to the Commission at its Regular Staff Conference on December 19, 2022. The Public Staff stated that it had reviewed the Application and determined it to be in compliance with the requirements of N.C.G.S. § 62-110.1(a) and Commission Rule R8-64. The Public Staff further stated that the registration statement contains the certified attestations required by Commission Rule R8-66(b). Therefore, the Public Staff recommended approval of the certificate and registration for the facility.

After careful consideration, the Commission finds good cause to approve the application and issue the attached certificate for the proposed solar photovoltaic generating facility. The Commission further finds good cause, based upon the foregoing and the entire record in this proceeding, to accept registration of the facility as a new renewable energy facility. The Applicant shall annually file the information required by Commission Rule R8-66 on or before April 1 of each year and is required to participate in the NC-RETS REC tracking system (http://www.ncrets.org) in order to facilitate the issuance of renewable energy certificates.

BY THE COMMISSION: On December 6, 2022, Virginia Electric and Power Company, d/b/a Dominion Energy North Carolina (DENC or Company), filed a request to extend existing Schedule LGS-RTP¹ from December 31, 2022, the current expiration date of the Schedule, through and including the earlier of March 31, 2023, or the effective date of a revised Schedule LGS-RTP-CBL.

DENC stated that no customers have enrolled in Schedule LGS-RTP-CBL. DENC also stated that the Company had been engaged in discussions with the Carolina Industrial Group for Fair Utility Rates regarding revisions to the tariffs, and that due to the ongoing discussions and the upcoming holidays, the Company was requesting an extension of the termination date of the Schedule.

The Public Staff presented this matter at the Regular Staff Conference on December 19, 2022, and recommended approval of the request. The Public Staff clarified that the request was applicable only to "Schedule LGS-RTP-Customer Baseline Load Day-Ahead Hourly Pricing, Large General Service Experimental," which provides an opportunity for customers served under Schedule 6L to also have a portion of their electric loads served under a real time hourly energy rate design using a locational marginal pricing algorithm. The Public Staff further clarified that it was aware of confidential discussions between DENC and potential customers to address the rate design barriers that were preventing the customers from subscribing to service under Schedule LGS-RTP-CBL.

Based upon the foregoing, the Commission approves the request as filed.

¹ Per the Compliance Filing made by DENC on July 28, 2020, Schedule LGS-RTP is comprised to two separate tariffs. The first is "Schedule LGS-RTP Customer Baseline Load Day-Ahead Hourly Pricing, Large General Service Experimental" (Schedule LGS-RTP-CBL) which establishes the terms and rates associated with customer loads that are billed under companion Schedule 6L. The second tariff is "Schedule LGS-RTP Economic Development Day-Ahead Hourly Pricing, Large General Service Experimental" which establishes the terms and rates for customer loads associated with new economic development.

IT IS, THEREFORE, ORDERED as follows:

- 1. That "Schedule LGS-RTP Customer Baseline Load Day-Ahead Hourly Pricing, Large General Service Experimental" is hereby revised to remain in effect through the earlier of March 31, 2023, or the effective date of a revised Schedule LGS-RTP-CBL.
- 2. That DENC shall file within 10 days of this order, revised tariffs reflecting the revised expiration date.

ORDER APPROVING TARIFF REVISION AND REQUIRING CUSTOMER NOTICE

BY THE COMMISSION: On October 21, 2022, Carolina Water Service, Inc. of North Carolina (CWSNC or Company) as emergency operator of Mountain Air Utilities Corporation (MAUC), filed a verified petition with the North Carolina Utilities Commission (Commission) pursuant to N.C. Gen. Stat. § 62-133.11, requesting authority to amend its tariff for the purpose of passing along to MAUC's approximately 424 residential and 25 commercial sewer customers in Mountain Air Development in Yancey County, North Carolina, an increase in the costs of purchasing sewer service from the Town of Burnsville (Burnsville). N.C.G.S. § 62-133.11(a) provides that the Commission shall allow a water or sewer utility to adjust its rates approved pursuant to N.C.G.S. § 62-133 to reflect changes in its costs based solely on changes in the rates imposed by third-party suppliers of purchased water or sewer service.

CWSNC stated that, effective July 1, 2022, Burnsville increased its minimum monthly sewer rate by \$1.38, increasing the rate from \$45.60 to \$46.98. CWSNC requested to increase the monthly flat rate sewer charge applicable to MAUC's residential sewer customers and the monthly base charge applicable to MAUC's metered commercial sewer customers in Mountain Air Development for service rendered on and after July 1, 2022. The requested increase passes along the increase in the cost of purchasing sewer service from Burnsville.

On May 4, 2021, in its Order Appointing Emergency Operator and Requiring Customer Notice issued in Docket No. W-1148, Sub 20, the Commission appointed CWSNC as emergency operator of the MAUC water and wastewater utility systems effective May 10, 2021.

The current rates have been in effect since September 20, 2021, when they were approved by the Commission in its Order Approving Tariff Revision and Requiring Customer Notice issued in Docket No. W-1148, Sub 21. The present and proposed rates are as follows:

The Public Staff – North Carolina Utilities Commission (Public Staff) presented this matter at the Commission's Staff Conference on December 19, 2022. The Public Staff stated: (1) it has reviewed Burnsville's rates and the Company's request; and (2) it recommends the Commission approve the tariff revision at the proposed rates for service rendered on and after the date of this order and require customer notice.

Based upon the foregoing, the Commission concludes that CWSNC should be allowed to pass through the costs associated with the increased purchased sewer expense.

IT IS, THEREFORE, ORDERED as follows:

- 1. That CWSNC is granted a revision to Appendix A of its tariff for sewer utility service in Mountain Air Development in Yancey County, North Carolina, as set forth herein:
- 2. That the revised Appendix A attached hereto is approved and is deemed filed with the Commission pursuant to N.C.G.S. § 62-138. This Schedule of Rates shall become effective for service rendered on and after the date of this Order; and
- 3. That a copy of the Notice to Customers, attached hereto as Appendix B, shall be mailed with sufficient postage or hand delivered by the Company to all MAUC's affected customers in Mountain Air Development contemporaneously with the next billing of customers; and that the Company shall submit to the Commission the attached Certificate of Service, properly signed and notarized, no later than 10 days after the date of the next billing of customers.

Notice is hereby given that the North Carolina Utilities Commission has granted Carolina Water Service, Inc. of North Carolina (CWSNC or Company) as emergency operator, an increase in its sewer rates for customers in Mountain Air Development in Yancey County, North Carolina.

CWSNC filed a verified petition with the Commission pursuant to N.C. Gen. Stat. § 62-133.11, requesting authority to amend its tariff for the purpose of passing along to sewer customers in Mountain Air Development in Yancey County an increase in the cost of purchasing sewer service from the Town of Burnsville (Burnsville). N.C.G.S. § 62-133.11(a) provides that the Commission shall allow a water or sewer utility to adjust its rates approved pursuant to N.C.G.S. § 62-133 to reflect changes in its costs based solely on changes in the rates imposed by third-party suppliers of purchased water or sewer service.

The Public Staff has reviewed the rates and recommended that CWSNC be allowed to increase both its residential sewer flat rate and commercial sewer base charge by \$1.38 per month for the increased cost of purchasing sewer treatment from Burnsville. The new sewer rates are as follows:
