NOTICE IS HEREBY GIVEN that on May 14, 2021, Filo Solar LLC (Applicant), filed an application seeking a certificate of public convenience and necessity pursuant to N.C. Gen. Stat. § 62-110.1(a) for construction of an 80-MW solar generating facility to be located along Coggins Road, near the City of Biscoe, Montgomery County, North Carolina. Applicant's site layout illustrating the footprint of the facility may change to some degree based on government land use requirements, interconnection requirements, or similar factors. Applicant plans to sell the electricity to Duke Energy Progress, LLC.

Details of the application may be obtained from the Office of the Chief Clerk of the North Carolina Utilities Commission on the Commission's website at www.ncuc.net.

If a complaint is received within ten days after the last date of the publication of this notice, the Commission will schedule a public hearing to determine whether a certificate should be awarded, will give reasonable notice of the time and place of the hearing to the Applicant and to each complaining party, and will require the Applicant to publish notice of the hearing in this newspaper. If no complaint is received within the time specified above and if the Commission does not order a hearing upon its own initiative, the Commission will enter an order awarding the certificate sought by the Applicant.


