Dear Chief Clerk:

A certificate of public convenience and necessity for a 5.0-MW $_{AC}$ solar facility for Belafonte Farm, LLC (Belafonte) was granted on May 12, 2015. Due to siting issues, the Applicant has determined the facility constructed will not exceed 3.4MW $_{AC}$ and the footprint of the proposed facility has shifted west. The Applicant's lease covers this additional land.

Enclosed and marked as "Belafonte Farm, LLC - Amended Application Exhibit" is an amended proposed layout. A revised location description is as follows:

The Facility will be located on the east side of South U.S. 117 Alternate, south of the intersection with Broadhurst Road, and north of E. Albritton Street (also known as State Road 1316), in the Township of Faison, NC, Duplin County.

Due to the change of the site location, we understand the Commission will enter an Order Requiring Publication providing an amended Public Notice and directing the Clerk to forward the amended application to the Clearinghouse. Furthermore, the Applicant requests that the Commission issue an Amended Certificate of Public Convenience and Necessity to reflect the reduction.
