### **Late Filed Exhibit No. 3 – Prepaid Customers**

#### **Docket No. E-7, Sub 1214**

**Request:** Disconnect for non-payment experience for active DEC SC Prepaid Advantage customers in comparison to their post-pay disconnect for non-payment experience.

**Response:** As of September 6, 2020, approximately 76 percent of the active Duke Energy Carolinas Prepaid Advantage customers in South Carolina had a post-pay billed account prior to enrolling in the Prepaid Advantage program.

About half of these customers, 51 percent, were disconnected for non-payment less than or equal to the same number of times via prepay billing in comparison to their post-pay billed account.

Slightly less than half of the customers, 49 percent, were disconnected for non-payment more times via prepay billing in comparison to their post-pay billed account.
