On January 29, 2009, Duke Energy Carolinas, LLC (Duke) filed a motion for reconsideration of the order issued by the Commission in this docket on December 31, 2008. On February 2, 2009, the Commission entered an order scheduling the filing of initial briefs, reply briefs and an oral argument on Duke's motion for reconsideration. The present dates for those filings and the oral argument are February 25, March 11 and March 16, 2009, respectively.

The undersigned counsel for the Attorney General's Office (AGO) will be unable to participate in the oral argument on March 16 because of a family medical need. The AGO has consulted with counsel for Duke and the Public Staff. Counsel for Duke and the Public Staff do not object to the Commission rescheduling the oral argument, initial briefs and reply briefs. The best date for the AGO, Duke and Public Staff for the rescheduled oral argument would be Wednesday, March 25, 2009. In addition, if the Commission grants this motion, the AGO requests that the dates for filing of initial and reply briefs be extended one week.

Wherefore, pursuant to Commission Rule R1-7, the AGO respectfully moves the Commission to reschedule the oral argument on Duke's motion for reconsideration to Wednesday, March 25, 2009, and to extend the dates for filing initial briefs and reply briefs to Wednesday, March 4 and Wednesday, March 18, 2009, respectively.


