NOW COMES Public Service Company of North Carolina, Inc., d/b/a Dominion Energy North Carolina ("PSNC" or the "Company"), by and through counsel and, pursuant to the North Carolina Utilities Commission's (the "Commission"), *Order Requesting Comments* issued on May 12, 2022, in the above-captioned proceeding, respectfully requests that the Commission enter an order granting an extension of time until August 26, 2022, for the Company to file reply comments in this docket.

In support of this motion, the Company shows the Commission the following:

1. The deadline for the filing of reply comments by the Company and other interested parties is currently Wednesday, July 27, 2022.
2. Initial comments were filed by the parties on June 29, 2022.
3. Due to other pending matters, PSNC needs additional time to consider the parties' comments and the Public Staff's proposed rule changes and to complete its reply comments. A thirty-day extension until August 26, 2022, will enable the Company to fully respond.
4. The Company has contacted the other parties to this proceeding, and none of them has objected to the extension of time requested herein. Counsel for Piedmont

Natural Gas Company, Inc (“Piedmont”) allows PSNC to represent that Piedmont supports this request.

WHEREFORE, Public Service Company of North Carolina, Inc. respectfully requests that the Commission:

1. Issue an Order granting an extension of time through and including August 26, 2022, for the Company to file reply comments; and
2. Grant such other relief as the Commission may deem appropriate.
