BY THE HEARING EXAMINER: On March 22, 2021, Clarke Utilities, Inc. (Clarke), filed an application with the North Carolina Utilities Commission (Commission) seeking authority to increase its rates for providing water and sewer utility service in all of its service areas in Franklin, Granville, and Wake Counties, North Carolina. The present rates have been in effect since January 1, 2017 based on orders issued in Docket Nos. M-100, Sub 138 and W-1215, Sub 8.

On April 19, 2021, the Commission issued an Order establishing general rate case and suspending rates. On May 19, 2021, the Commission issued an Order scheduling hearings, and requiring customer notice. On May 25, 2021, Clarke filed a certificate of service indicating that customer notice had been given in accordance with the Commission's May 19, 2021 Order. The Public Staff and the Commission have not received any protests from Clarke's customers.

On June 17, 2021, the Public Staff filed the Affidavit of John R. Hinton, Economic Research Division Director. On June 21, 2021, the Public Staff filed the testimony and exhibits of Gina Y. Casselberry, Utilities Engineer, and Charles A. Akpom, Staff Accountant.

On July 8, 2021, Clarke filed a document confirming that Clarke agreed with the Public Staff's recommendations and adjustments.

On July 13, 2021, Clarke filed its proposed order for the Commission's consideration. On July 19, 2021, the Public Staff filed its proposed order for the Commission's consideration.

On, or about, July 19, 2021, Clarke filed notice stating that Clarke waived the right to file exceptions in to the rate increase order and requesting that the increased approved rates be effective the date of the order.

Based upon the foregoing, the verified application, the affidavit of Mr. Hinton, the testimony and exhibits of Ms. Casselberry and Mr. Akpom and the entire record in this matter, the Commission makes the following:

FINDINGS OF FACT

- 1. Clarke is a public utility as defined in North Carolina Gen. Stat. § 62-3(23) and is before the Commission pursuant to its application for an increase in rates and charges for water and waste water utility service under N.C.G.S. § 62-133.
- 2. The updated test year established for use in this proceeding is the 12-month period ending on December 31, 2020.
- 3. At the end of the test period, Clarke provided water service for 593 residential metered customers and sewer service for 310 residential and 2 commercial metered customers.
 - 4. Clarke provides very good service to its customers.
- 5. Clarke's present and proposed rates filed in the application are as follows:

- 6. The original cost rate base for use in this proceeding is \$184,211, of which \$72,385 is attributable to water operations and \$111,827 is attributable to sewer operations.
- 7. The level of operating revenue deductions requiring a return (total operating expenses, excluding regulatory fee and income taxes) is \$203,640 for water operations and \$183,821 for sewer operations.
- 8. The operating ratio method set forth in N.G.G.S. § 62-133.1, which allows a return on operating revenue deductions, is the proper method for determining Clarke's revenue requirement.
- 9. The level of ongoing annual service revenues under present rates is \$185,106 for water operations and \$159,073 for sewer operations.
- 10. The level of ongoing annual service revenues under Clarke's proposed rates is \$257,723 for water operations and \$199,340 for sewer operations.
- 11. After an investigation and an audit of Clarke's records, the Public Staff recommended an increase in water service revenues of \$37,519 resulting in a recommended total revenue requirement of \$222,436 for water operations and an increase in sewer service revenue of \$40,078 resulting in a recommended sewer revenue requirement of \$199,151. Clarke agrees with the Public Staff's recommendations.
- 12. A return of 7.00% on water operating revenue deductions is reasonable for use in this proceeding. The total annual water service revenue necessary to allow Clarke to earn the 7.00% return is \$222,625, an increase of \$37,519 for water operations.
- 13. Clarke and the Public Staff have agreed to the sewer revenue requirement of \$199,151, which is the revenue requirement resulting from

Clarke's applied for rates. The resulting return from this \$199,151 revenue requirement is 6.31%.

14. The following rates and rate structures, recommended by the Public Staff and accepted by Clarke will produce the total of \$421,965 in annual service revenue necessary to allow Clarke to earn the aforementioned 7.00% return for water operations and 6.31% return for sewer operations:

15. The rates recommended by the Public Staff and agreed to by Clarke are not in excess of a just and reasonable level and should be approved.

EVIDENCE AND CONCLUSIONS FOR FINDINGS OF FACT 1-15

The evidence for these findings of facts is contained in the verified application filed in this docket; the affidavit, testimonies, and exhibits of the Public Staff witnesses Akpom, Casselberry, and Hinton; and the Commission's records. This evidence is uncontroverted.

Based upon the entire record in this proceeding, the Commission is of the opinion that Clarke has sufficiently demonstrated the need to increase its rates for providing water and sewer utility service in all its service areas in Franklin, Granville, and Wake Counties, North Carolina. The Commission, therefore, concludes that the rates recommended by the Public Staff and agreed to by Clarke are just and reasonable and should be approved.

IT IS, THEREFORE, ORDERED as follows:

- 1. That the Schedule of Rates, attached as Appendix A, is approved and deemed to be filed with the Commission pursuant to N.C.G.S. § 62-138. Said Schedule of Rates is authorized to become effective for service rendered on and after the date of this Order.
- 2. That the Notice to Customers, attached as Appendix B, be mailed with sufficient postage, or hand delivered by Clarke, to all customers affected by the new rates no later than 10 days after the date of this Order; and that Clarke submit to the Commission the attached Certificate of Service properly signed and notarized not later than 15 days after the date of this Order.
