NOW COMES Duke Energy Carolinas, LLC (DEC or Company), by and through its counsel, and respectfully moves the North Carolina Utilities Commission (Commission) to extend the time for filing its response to comments related to DEC's Proposed Modifications to the PowerShare® Nonresidential Load Curtailment Program (Proposed Modifications). In support of this motion, DEC respectfully shows the Commission the following:

1. On October 9, 2023, DEC filed in this docket its Proposed Modifications pursuant to Commission Rule R8-68, setting forth changes to the program – originally approved by the Commission in this docket on February 26, 2009 – in its current form.

2. Pursuant to Commission Rule R8-68(d)(2), the deadline for parties to file comments, interventions, and protests related to the Proposed Modifications was November 8, 2023.

3. By motion dated November 1, 2023, the Public Staff requested that the deadline to file comments, interventions, or protests on the Proposed

Modifications be extended 9 calendar days, from November 8, 2023, to November 17, 2023.

4. On November 6, 2023, the Commission issued its Order Granting Extension of Time (Order) by which it extended to November 17, 2023, the date for the Public Staff and other interested parties to file a protest, petition for intervention or comments in this docket regarding DEC's Proposed Modifications.

5. In the Order, the Commission further provided that DEC has the right to respond to all such petitions for intervention, protests and comments within 10 days of each such filing.

6. On November 17, 2023, the Public Staff and CIGFUR III filed comments regarding the Proposed Modification.

7. Under the deadlines set forth in the Order, DEC's response(s) to comments are due on Monday, November 27, 2023.

8. Due to the press of other business, DEC requires additional time to draft its response. A fourteen-calendar day extension would provide DEC with sufficient time to file its response.

9. DEC therefore respectfully requests and moves that the deadline to file its response to comments on the Proposed Modifications be extended by fourteen calendar days, from November 27, 2023, to December 11, 2023.

10. DEC has contacted counsel for the Public Staff and CIGFUR III, which do not object to this motion.

WHEREFORE, DEC respectfully requests and moves that the deadline for to file its response to comments on the Proposed Modifications be extended by fourteen calendar days, from November 27, 2023, to December 11, 2023.
