BY THE PRESIDING COMMISSIONER: On October 5, 2020, in the above-captioned docket, the Commission issued a scheduling order which, among other things, required the Applicant, Pitt Solar, LLC (formerly known as Bethel NC 11 Solar, LLC), to file additional testimony on or before October 15, 2020, required the Public Staff to file direct testimony and exhibits on or before October 29, 2020, and allowed the Applicant to file rebuttal testimony on or before November 12, 2020.

On October 16, 2020, the Applicant prefiled supplemental testimony of Linda Nwadike.

On October 26, 2020, the Public Staff filed a Motion for Extensions of Time. In the motion, the Public Staff seeks an extension of time until November 12, 2020, to file its direct testimony and exhibits. In addition, the Public Staff seeks an extension until November 25, 2020, for the Applicant to file its rebuttal testimony and exhibits, if any. In support of its motion the Public Staff states that its testimony relates to testimony it will be filing in Docket E-100, Sub 170, which is due on October 28, 2020, and that the Applicant will be modifying its application. The Public Staff also asserts in the motion that the Applicant does not oppose the motion.

Based on the Public Staff's motion and the record herein, the Presiding Commissioner finds good cause to grant the Public Staff's motion. The expert witness hearing scheduled in this docket for December 3, 2020, is canceled and shall be rescheduled by subsequent order of the Commission.

IT IS, THEREFORE, ORDERED:

1. That the Public Staff shall file its direct testimony and exhibits on or before November 12, 2020;

2. That the Applicant may file its rebuttal testimony and exhibits on or before November 25, 2020; and

3. That the expert witness hearing scheduled in this docket for December 3, 2020, is hereby canceled and will be rescheduled by subsequent order of the Commission.
