On April 30, 2019, Duke Energy Carolinas, LLC ("DEC" or the "Company") filed the Supplemental Testimony, Exhibits and Workpapers of Kimberly D. McGee, which resulted in an increase in the amount requested in the Company's original application in this docket. For that reason, DEC is attaching a Second Public Notice to reflect the updated proposed increase.

The Company respectfully requests that the North Carolina Utilities Commission ("Commission") review the proposed Second Public Notice as soon as possible to allow DEC sufficient time to request that newspapers of general circulation in its service area publish the notice before the June 11, 2019 hearing. Additionally, due to the timing of the Company's supplemental filing and in light of the fact that notice of the public hearing has previously been published in accordance with the Commission's March 18, 2019 order in this docket, the Company asks that, consistent with past practice, the Commission require the Company to publish the Second Public Notice on two dates prior to the public hearing, with the publications preferably being several days apart and the first publication of which shall occur as soon as reasonably practicable.

NOTICE IS HEREBY GIVEN that the North Carolina Utilities Commission has scheduled a public hearing on an annual fuel and fuel-related charge adjustment proceeding for Duke Energy Carolinas, LLC (DEC). The public hearing has been scheduled to begin Tuesday, June 11, 2019, at 9:30 a.m., in Commission Hearing Room 2115, Dobbs Building, 430 North Salisbury Street, Raleigh, North Carolina. The proceeding is being held pursuant to the provisions of N.C.G.S. § 62-133.2 and Commission Rule R8-55 for the purpose of determining whether an increment or decrement rider is required in order to reflect changes in fuel and fuel-related costs over or under the base fuel rate established for DEC in its last general rate case. Public witness testimony will be received in accordance with Commission Rule R1-21(g).

DEC filed an application and testimony relative to the subject matter of the proceeding on February 26, 2019. According to DEC's initial application, the proposed changes in fuel rates would result in an increase of the present fuel rates of all customer classes, with the amount of the increase varying for different customer classes.

On March 8, 2019, the Commission issued an Order Scheduling Hearing, Requiring Filing of Testimony, Establishing Discovery Guidelines, and Requiring Public Notice (Scheduling Order). The Scheduling Order, among other things, required DEC to publish a Public Notice of the hearing date, time, and place, and of the proposed changes in monthly fuel rates.

Through supplemental testimony and exhibits filed on April 30, 2019, after the Public Notice of the original proposed fuel charges had been published by DEC pursuant to the Commission's Scheduling Order, DEC revised its proposed monthly fuel rates. The revisions, if approved by the Commission, would result in fuel charges higher than the charges stated in the original Public Notice published by DEC. In the case of the monthly bill of a typical residential customer using 1,000 kilowatt hours per month, DEC's revised application proposes would result in an increase of \$1.72, excluding the regulatory fee. The proposed changes in all customers' fuel rates would be effective for service rendered on and after September 1, 2019.

Further information may be obtained from the Office of the Chief Clerk, North Carolina Utilities Commission, Raleigh, North Carolina, where a copy of DEC's application is available for review by the public, and on the Commission's website at www.ncuc.net.

The Public Staff is authorized by statute to represent consumers in proceedings before the Commission. Correspondence concerning the fuel adjustment proceeding and the hearing scheduled thereon should be directed to the Public Staff. Written statements to the Public Staff should include any information which the writers wish to be considered by the Public Staff in its investigation of the matter. Such statements should be addressed to Mr. Christopher J. Ayers, Executive Director, Public Staff, 4326 Mail Service Center, Raleigh, North Carolina 27699-4300.

The Attorney General is also authorized by statute to represent consumers in proceedings before the Commission. Written statements are not evidence unless the writers appear at a public hearing and testify concerning the information contained in their written statements.

Persons desiring to intervene as formal parties should file a petition under North Carolina Utilities Commission Rules R1-5 and R1-19.
