BY THE COMMISSION: On January 8, 2014, in Docket No. SP-2910, Sub 4, the Commission issued a certificate of public convenience and necessity (CPCN), to SoINCPower1, LLC (SoINCPower1), for construction of a 5-MW solar photovoltaic electric generating facility to be located at 662 W. Battleboro Ave. in Battleboro, Nash County, North Carolina. In addition, the Commission accepted the registration statement of the facility as a new renewable energy facility.

On May 15, 2014, SolNCPower1 and SolNCPower5, LLC (SolNCPower5 or Applicant), filed a statement with the Commission in Docket Nos. SP- 2910, Sub 4 and SP-3717, Sub 0 requesting that the Commission transfer the CPCN and registration for the facility from SolNCPower1 to SolNCPower5.

On June 3, 2014, the Commission issued an Order transferring the CPCN and registration for the facility from SolNCPower1 to SolNCPower5, canceling the CPCN issued to SolNCPower1, issuing a new CPCN to SolNCPower5, and closing Docket No. SP-2910, Sub 4.

On July 28, 2014, SoINCPower5 filed an amended application for a CPCN stating that the proposed site plan of the facility has changed due to the addition of a second parcel of land adjacent to the original proposed site.

On the basis of the amended application, the Commission finds good cause to cancel the CPCN issued to SolNCPower5. Further, the Commission concludes that the Applicant should be required (1) to publish notice of the application in the manner required by G.S. 62-82(a) and file an affidavit of publication with the Commission and (2) to mail a copy of the application and notice, no later than the first date that such notice is published, to the electric utility to which the Applicant plans to sell and distribute the electricity and file a signed and verified certificate of service that the application and notice have been provided to the utility. The Chief Clerk of the Commission will deliver copies of the notice to the Clearinghouse Coordinator of the Office of Policy and Planning of the Department of Administration for distribution by the Coordinator to State agencies having an interest in the application.

If a complaint is received within ten days after the last date of the publication of the notice, the Commission will schedule a public hearing to determine whether a certificate should be awarded, will give reasonable notice of the time and place of the hearing to the

Applicant and to each complaining party, and will require the Applicant to publish notice of the hearing in the newspaper in which the notice of the application was published. If no complaint is received within the time specified above, the Commission may, upon its own initiative, order and schedule a hearing to determine whether a certificate should be awarded. If the Commission orders a hearing upon its own initiative, it will require notice of the hearing to be published by the Applicant in the newspaper in which the notice of the application was published. If no complaint is received within the time specified and the Commission does not order a hearing upon its own initiative, the Commission will enter an order awarding the certificate.

The Commission cannot take any action until after the Applicant has filed both the affidavit of publication and the certificate of service. The Applicant is urged to file both the affidavit and the certificate promptly following the last date of publication of the notice.

IT IS, THEREFORE, ORDERED as follows:

- 1. That the certificate of public convenience and necessity issued to SoINCPower5, LLC, in Docket No. SP-3717, Sub 0 for a solar photovoltaic facility to be located at 662 W. Battleboro Ave. in Battleboro, Nash County, North Carolina shall be, and is hereby, cancelled.
- 2. That the Applicant shall publish the Public Notice, attached as Attachment A hereto, once each week for four successive weeks in the manner required by G.S. 62-82(a) and shall file an affidavit of publication with the Commission;
- 3. That the Applicant shall mail a copy of the application and notice, no later than the first date that such notice is published, to the electric utility to which the Applicant plans to sell and distribute the electricity and file a signed and verified certificate of service that the application and notice have been provided to the utility;
- 4. That the Chief Clerk of the Utilities Commission will deliver copies of the notice to the Clearinghouse Coordinator of the Office of Policy and Planning of the Department of Administration for distribution by the Coordinator to State agencies having an interest in the application;
- 5. That the Commission will proceed as it deems appropriate after the filing of the affidavit of publication and the certificate of service.

If no complaint is received within the time specified above and if the Commission does not order a hearing upon its own initiative, the Commission will enter an order awarding the certificate sought by the Applicant.
