**Now Comes Aqua North Carolina, Inc.** (“Aqua” or “Company”), by and through its President, Shannon V. Becker, and files this annual report on the status of the Heater Acquisition Incentive Account (“AIA”), in accordance with the North Carolina Utilities Commission (“NCUC” or “Commission”) directives. This annual reporting requirement was initially established in Docket No. W-218, Sub 274 by Decretal Paragraph No. 19 of the Commission Order dated April 8, 2009 (p. 37), and was modified by the Commission Order of November 3, 2011, in Docket No. W-218, Sub 319, Decretal Paragraphs 7 – 9 (pp. 112-113). Decretal Paragraph No. 22 of the Rate Case Order entered by the Commission in Docket No. W-218, Sub 497 on December 18, 2018, directed Aqua to file future AIA annual reports in Docket No. W-218, Sub 497A, until further order of the Commission. Decretal Paragraph No. 20 of the Rate Case Order entered by the Commission in Docket No. W-218, Sub 526 on October 26, 2020, directed Aqua to continue to file its Annual Heater Acquisition Incentive Account Report.

The Commission, in the above-referenced Sub 319 Order, specified an expansion of the information previously required to be included in this annual report. The Company hereby responds to the Commission’s instruction that it

provide cumulative information on all activity to date, as well as on the status of matters currently in progress.

By way of background, the Heater AIA was established in 2004 in Docket No. W-274, Sub 465, in the Commission's ruling on the request for transfer of ownership of the stock and assets of Heater Utilities, Inc. ("Heater") from Allele Water Services, Inc. ("Allele") to Aqua America, Inc. ("Aqua America"). Consistent with the Stipulation between the Public Staff and Aqua in that proceeding, which became embodied in the Commission Order, the Acquisition Premium (\$18 million) associated with the purchase transaction was accounted for by establishing on Heater's books an Acquisition Incentive Account and an Acquisition Adjustment Account.

The Commission stated in its Order of May 26, 2004, that the Acquisition Incentive Account "...will be converted to rate base in connection with the acquisition and upgrade of nonviable systems in North Carolina..." in a manner that the Order describes. (W-274, Sub 465, et seq., Order of May 26, 2004, page 1, ¶ "a".) The Commission Order notes, in relevant part, that:

b. The Acquisition Incentive Account may be converted to rate base in connection with the acquisition and upgrade of nonviable water and sewer systems in North Carolina. Heater will be active in pursuing the acquisition of such systems as identified by the Commission, the Department of Environment and Natural Resources (DENR) or the Public Staff. Nonviable systems are generally considered to be systems whose current owner(s) do not have the financial, technical, or managerial capacity to provide adequate service. Such systems may include, by way of illustration: (i) systems for which an emergency operator has been appointed; (ii) systems that have received repeated Notices of Violation from DENR; or (iii) systems needing significant capital improvements that are not economically feasible. The Acquisition Incentive Account will be used solely for acquisition of privately-

owned systems that would fall under regulation by the Commission.

*Docket No. W-274, Sub 465, Order of May 26, 2004, page 2, ¶ b.*

Thus, the Commission, in adopting the Stipulation, established a mechanism whereby Heater (now Aqua) could recover some of the Acquisition Premium if Aqua seeks, acquires, and invests in nonviable water and wastewater systems. For every dollar spent on the purchase price for acquiring nonviable systems and that is allowed in rate base, and for every dollar that is used to upgrade such systems to State regulatory standards [DWQ, Division of Health Services (DHS), NCUC, etc.], Aqua may include a like amount from the AIA in rate base, subject to compliance with a range of requirements that were set forth in the Order. These criteria for use of AIA were intended, essentially, to strictly assure prudence and reasonableness in purchase price and investment and overall fairness both to Aqua's existing customers and to the customers of acquired companies.

In compliance with the Commission's Orders requiring an annual report on the status of this AIA, Aqua submits the following:

1. That the prior annual reporting requirement related to the Heater Acquisition Incentive Account and required by final Order dated April 8, 2009, in Docket No. W-218, Sub 274, was revised by Commission Order in Docket No. W-218, Sub 319 to require that Aqua shall file an annual report on June 30<sup>th</sup> of each year on the cumulative status of the Heater Acquisition Incentive Account. Such report is to provide:

- (a) a listing of the name of each company or system acquired;
- (b) the corresponding docket number in which such treatment was approved by the Commission;
- (c) the purchase price for each company or system acquired;
- (d) a description of all improvements made to date, by company or system;
- (e) an accounting of all money spent on improvements for each company or system such that the total dollar amount expended is shown;
- (f) a detailed description of the improvements still to be made for each company or system;
- (g) an estimate of the total dollar amount related to improvements still to be made for each company or system;
- (h) a timeframe for the remaining improvements to be completed related to each company or system; and
- (i) a summary schedule which sets forth the total amount of the Heater Acquisition Incentive Account, the amount used to date, and the remaining balance in the Heater Acquisition Incentive Account.

The information requested in Ordering Paragraph No. 8, items (a)-(i) listed above, is outlined specifically for the systems subject to the Heater Acquisition Incentive Account in the attached Appendix A-1 Status of Systems Subject to Additional AIA Since Last Report

(June 30, 2021); Appendix A-2 reflects the same information for Systems With AIA Matching Complete As Of Last Report (June 30, 2021); and Appendix B shows a “Detailed Summary per System.”

2. The reconciliation referenced above as Item (i) is contained in Appendix C, attached. It is a summary schedule showing the total amount of the Heater Acquisition Incentive Account, the amount used to date, and the remaining balance in the Heater Acquisition Incentive Account.

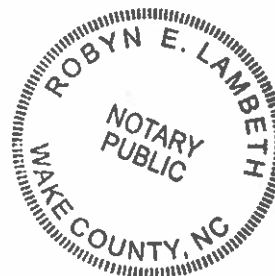
