Late-filed Exhibit #3 of Sandler Utilities at Mill Run: likely sequence of events related to transfer of Eagle Creek wastewater system from Sandler Utilities at Mill Run to Currituck Water and Sewer

- 1. The parties file their late-filed exhibits with the North Carolina Utilities Commission (NCUC)
- 2. Sandler Utilities at Mill Run (Sandler) and/or the Attorney General's office move to join Currituck Water and Sewer (CWS) as a defendant and for entry of the Second Amended Consent Judgment in Superior Court, and the Second Amended Consent Judgment is entered by the Superior Court¹
- 3. Sandler files joint proposed order with NCUC
- 4. CWS posts bond with NCUC
- 5. NCUC issues acceptance order on bond
- 6. NCUC issues order approving transfer
- 7. Closing (Sandler- CWS)
- 8. CWS and/or Sandler file name and ownership change for treatment plant permit (WQ0014306)
- 9. CWS and/or Sandler file name and ownership change for collection system permit (WQCS00290)
- 10. If applications satisfy applicable regulatory requirements, the Division of Water Resources issues collection system and treatment plant permits in CWS's name after adherence to applicable permitting procedures.
- 11. Second Amended Consent Judgment becomes effective
- 12. Sandler files for Superior Court dismissal of Sandler as a party in Currituck County injunctive action.

¹ The filing of the motion to join CWS as a defendant and for entry of the Second Amended Consent Judgment need not occur at any particular point in this sequence of events so long as the Second Amended Consent Judgment is entered prior to Closing. Provided the Commission's transfer approval is conditioned upon entry of the Second Amended Consent Judgment, the Second Amended Consent Judgment need not be entered prior to the Commission's transfer approval. The Parties intend to file the motion within the next thirty days.
