P1. <u>DOCKET NO. W-175, SUB 14 – OVERHILLS WATER COMPANY, INC. – REQUEST FOR TARIFF REVISION</u>

EXPLANATION: On June 12, 2018, Overhills Water Company, Inc. (Overhills), filed a petition with the Commission requesting authority to amend its tariff for the purpose of passing along to its approximately 291 residential customers in Overhills Park Subdivision and its bulk water utility customer, Carolina Sands Mobile Home Park, in Cumberland County, North Carolina, the increase in cost of purchasing water from the Town of Spring Lake (Town). On July 23, 2018, Overhills filed the petition verification.

Effective August 1, 2018, the Town will increase its bulk water usage rate to Overhills by \$0.15 per 1,000 gallons.

Overhills' current rates have been in effect since January 1, 2017, when they were approved by the Commission in its Order Approving Tariff Revision and Requiring Customer Notice issued in Docket Nos. W-175, Sub 13 and M-100, Sub 138.

The Public Staff has reviewed Overhills' request and recommends that Overhills be allowed to increase its rates as shown below:

Under the new rates, the average residential customer's monthly water and sewer bill will increase by \$0.97, from \$43.50 to \$44.47 based upon 6,500 gallons usage. Overhills has agreed with the Public Staff's recommendation.

EXHIBIT: A proposed order is attached as <u>Exhibit No. P- 1</u>. RECOMMENDATION: (Furr/Henry/Little) That the Commission issue the proposed order approving the tariff revision at the rates recommended by the Public Staff.

P2. <u>DOCKET NO. W-1021, SUB 14 – WATERCREST ESTATES – REQUEST FOR TARIFF REVISION</u>

EXPLANATION: On June 27, 2018, Watercrest Estates (Watercrest) filed a verified petition with the Commission requesting authority to amend its tariff for the purpose of passing along to its customers in Watercrest Estates Mobile Home Park in Iredell County, North Carolina, the increases in costs of purchasing water and sewer services from the City of Statesville (City).

Effective July 1, 2018, the City increased its rates to Watercrest from \$7.55 per 1,000 gallons to \$7.79 per 1,000 gallons for water usage and from \$12.43 per 1,000 gallons to \$12.87 per 1,000 gallons for sewer usage. The City increased the base charge from \$19.13 to \$19.70 for water service and from \$28.25 to \$29.25 for sewer service.

Watercrest's current rates have been in effect since July 10, 2017, when they were approved by the Commission in its Order Approving Tariff Revision and Requiring Customer Notice issued in Docket No. W-1021, Sub 13.

The Public Staff has reviewed Watercrest's request and recommends that Watercrest be allowed to increase its rates as shown below:

Under the new rates, the average residential customer's monthly water and sewer bill will increase by \$1.92, from \$66.87 to \$68.79 based upon 2,800 gallons usage. Watercrest has agreed with the Public Staff's recommendation.

RECOMMENDATION: (Furr/Henry/Little) That the Commission issue the proposed order approving the tariff revision at the rates recommended by the Public Staff.

P3. <u>DOCKET NO. W-1166, SUB 18 – MECO UTILITIES, INC. – REQUEST FOR TARIFF REVISION</u>

EXPLANATION: On July 3, 2018, MECO Utilities, Inc. (MECO), filed a petition with the Commission requesting authority to amend its tariff for the purpose of passing along to its approximately 266 customers in Mobile Estates Mobile Home Park in Wake County, North Carolina, the increases in costs of purchasing water and sewer services from the Town of Cary (Town). On July 20, 2018, MECO filed a revised verified petition.

Effective July 1, 2018, the Town increased its rates to MECO from \$5.26 per 1,000 gallons to \$5.42 per 1,000 gallons for water usage and from \$10.04 per 1,000 gallons to \$10.34 per 1,000 gallons for sewer usage. The Town also increased the monthly base charge from \$136.93 to \$141.04 for water service and from \$136.93 to \$141.04 for sewer service.

MECO's current rates have been in effect since May 4, 2018, when they were approved by the Commission in its Order Granting Partial Rate Increase and Requiring Customer Notice issued in Docket No. W-1166, Sub 17.

The Public Staff has reviewed MECO's request and recommends that MECO be allowed to implement its proposed rates as shown below:

Under the new rates, the average residential customer's monthly water and sewer bill will increase by \$1.74, from \$96.27 to \$98.01 based upon 3,700 gallons of usage.

RECOMMENDATION: (Furr/Henry/Little) That the Commission issue the proposed order approving the tariff revision at the proposed rates.

P4. <u>DOCKET NO. W-1240, SUB 15 – CHATHAM UTILITIES, INC. – REQUEST FOR TARIFF REVISION</u>

EXPLANATION: On July 3, 2018, Chatham Utilities, Inc. (Chatham), filed a petition with the Commission requesting authority to amend its tariff for the purpose of passing along to its approximately 144 customers in Chatham Estates Manufactured Housing Community in Wake County, North Carolina, the increases in costs of purchasing water and sewer services from the Town of Cary (Town). On July 20, 2018, Chatham filed a revised verified petition.

Effective July 1, 2018, the Town increased its rates to Chatham from \$5.26 per 1,000 gallons to \$5.42 per 1,000 gallons for water usage and from \$10.04 per 1,000 gallons to \$10.34 per 1,000 gallons for sewer usage. The Town also increased the monthly base charge from \$110.93 to \$114.26 for water service and from \$110.93 to \$114.26 for sewer service.

Chatham's current rates have been in effect since August 21, 2017, when they were approved by the Commission in its Order Approving Tariff Revision and Requiring Customer Notice issued in Docket No. W-1240, Sub 14.

The Public Staff has reviewed the Chatham's request and recommends that Chatham be allowed to implement its proposed rates as shown below:

Under the new rates, the average residential customer's monthly water and sewer bill will increase by \$1.60, from \$79.61 to \$81.21 based upon 3,400 gallons of usage.

RECOMMENDATION: (Furr/Henry/Little) That the Commission issue the proposed order approving the tariff revision at the proposed rates.

P5. <u>DOCKET NO. W-1300, SUB 15 – OLD NORTH STATE WATER COMPANY, LLC – APPLICATION FOR CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY</u>

EXPLANATION: On October 27, 2017, Old North State Water Company, LLC (Old North State), filed an application seeking a certificate of public convenience and necessity to provide wastewater utility service in Stateside Subdivision in Onslow County, North Carolina, and approval of rates. Old North State proposes to charge a monthly flat rate of \$45.00 per single family residential equivalent (SFRE). Old North State expects eventually to serve 201 wastewater customers in the first phase and eventually 400 wastewater customers at buildout in Stateside Subdivision consisting of Bennett Place, Roanoke Bay, and Somerset Place. The service area is shown on plans filed with the Application.

The North Carolina Department of Environmental Quality (NCDEQ), Division of Water Resources (DWR), Water Quality Permitting Section, has issued permit number WQ0035809, dated March 1, 2017, for the construction of the Stateside Wastewater Treatment Plant (Stateside WWTP). NCDEQ, DWR, Water Quality Permitting Section, has issued permit number WQ0038128, dated May 11, 2017, for the construction and operation of the Stateside Subdivision wastewater collection system.

Old North State has entered into an Agreement dated August 10, 2015 (Developer Agreement), with A. Sydes Construction, Inc., (Developer), under which Developer is installing the wastewater collection system and effluent infiltration ponds.

Old North State is requesting a connection fee of \$3,500 per SFRE for wastewater service, to be paid by the builder or person first requesting service to a particular lot. The Developer Agreement provides for Old North State to design and construct at its cost the WWTP at the approximate cost of \$1.6 million. The first 300 SFREs will pay connection fees being contributions in aid of construction totaling \$1,050,000. The Public Staff in future general rate cases will evaluate whether to recommend an excess plant rate base adjustment for the Stateside WWTP. Old North State is purchasing the wastewater system for \$3,500 per SFRE from Developer, payable quarterly based upon the number of connections installed during the previous quarter. The purchase price payments shall begin with the 301st connection to the wastewater collection system.

Old North State presently holds water franchises serving approximately 406 customers and wastewater franchises serving approximately 2,643 customers in North Carolina. Old North State's record of service is satisfactory.

Old North State has filed all exhibits required with the application.

The Public Staff is of the opinion that Old North State has the technical, managerial, and financial capacity to provide wastewater utility service in this franchise location and recommends that the certificate of public convenience and necessity be issued. The Public Staff further recommends that the Commission require posting of a \$10,000 bond

for the franchise in Stateside Subdivision. Old North State currently has \$600,000 of bonds posted with the Commission, which includes \$160,000 of unassigned funds, from which \$10,000 may be assigned to provide the bond recommended in this docket.

EXHIBIT: A proposed order is attached as Exhibit No. P-5.

RECOMMENDATION: (Darden/Feasel/Grantmyre) That the Commission issue the proposed order granting the franchise and approving the proposed rates.

P6. <u>DOCKET NO. W-1300, SUB 44 – OLD NORTH STATE WATER COMPANY, LLC – APPLICATION FOR CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY</u>

EXPLANATION: On November 13, 2017, Old North State Water Company, LLC (Old North State), filed an application seeking a certificate of public convenience and necessity to provide water utility service in Mendenhall Subdivision in Wake County, North Carolina, and approval of rates. Old North State proposes to charge its currently approved uniform water rates. Old North State expects eventually to serve 49 water customers in Mendenhall Subdivision. The service area is shown on plans filed with the Application.

The North Carolina Department of Environmental Quality, Division of Water Resources (DWR), Public Water Supply Section, has issued a plan approval letter for Mendenhall Subdivision. The plans are approved under serial number 17-00326, dated July 26, 2017.

Old North State has entered into a Water Agreement with Goetze Development Corporation and Cornerstone Realty Ventures, LLC, (Developer), under which Developer is installing at Developer's cost the water production, storage, treatment, and distribution system. Old North State is requesting a meter installation fee of \$70. Old North State is requesting a connection fee of \$500 per single-family residential equivalent unit (SFRE). Old North State is purchasing the water system for \$1,000 per SFRE from Developer, payable quarterly based upon the number of water service meters installed during the previous quarter.

Old North State presently holds water franchises serving approximately 406 customers and wastewater franchises serving approximately 2,643 customers in North Carolina. Old North State's record of service is satisfactory.

Old North State has filed all exhibits required with the application.

The Public Staff is of the opinion that Old North State has the technical, managerial, and financial capacity to provide water utility service in this franchise location and recommends that the certificate of public convenience and necessity be issued. The Public Staff recommends approval of the meter installation fee of \$70 and of the connection fee of \$500 per SFRE. The Public Staff further recommends that the Commission require posting of a \$10,000 bond for the franchise in Mendenhall Subdivision. Old North State currently has \$600,000 of bonds posted with the Commission, which includes \$160,000 of unassigned funds, from which \$10,000 may be assigned to provide the bond recommended in this docket.

EXHIBIT: A proposed order is attached as Exhibit No. P-6.

RECOMMENDATION: (Darden/Feasel/Grantmyre) That the Commission issue the proposed order granting the franchise and approving the proposed rates.

P7. DOCKET NO. W-1300, SUB 45 – OLD NORTH STATE WATER COMPANY, LLC – APPLICATION FOR CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY

EXPLANATION: On February 27, 2018, Old North State Water Company, LLC (Old North State), filed an application seeking a certificate of public convenience and necessity to provide water utility service in Stonewood Manor Subdivision in Wake County, North Carolina, and approval of rates. Old North State proposes to charge its currently approved uniform water rates. Old North State expects eventually to serve 51 water customers in Stonewood Manor Subdivision. The service area is shown on plans filed with the Application.

The North Carolina Department of Environmental Quality, Division of Water Resources (DWR), Public Water Supply Section, has issued a plan approval letter for Stonewood Manor Subdivision. The plans are approved under serial number 17-00670, dated August 18, 2017.

Old North State has entered into a Water Utility Agreement with Greenfield Communities – Stonewood, LLC, (Developer), under which Developer is installing at Developer's cost the water production, storage, treatment, and distribution system. Old North State is requesting a meter installation fee of \$70. Old North State is not requesting a connection fee. Old North State is purchasing the water system for \$500 per SFRE from Developer, payable quarterly based upon the number of water service meters installed during the previous quarter.

Old North State presently holds water franchises serving approximately 406 customers and wastewater franchises serving approximately 2,643 customers in North Carolina. Old North State's record of service is satisfactory.

Old North State has filed all exhibits required with the application.

The Public Staff is of the opinion that Old North State has the technical, managerial, and financial capacity to provide water utility service in this franchise location and recommends that the certificate of public convenience and necessity be issued. The Public Staff recommends approval of the meter installation fee of \$70. The Public Staff further recommends that the Commission require posting of a \$10,000 bond for the franchise in Stonewood Manor Subdivision. Old North State currently has \$600,000 of bonds posted with the Commission, which includes \$160,000 of unassigned funds, from which \$10,000 may be assigned to provide the bond recommended in this docket.

BY THE COMMISSION: On July 3, 2018, MECO Utilities, Inc. (MECO), filed a petition with the Commission requesting authority to amend its tariff for the purpose of passing along to its approximately 266 customers in Mobile Estates Mobile Home Park in Wake County, North Carolina, the increases in costs of purchasing water and sewer services from the Town of Cary (Town). On July 20, 2018, MECO filed a revised verified petition.

Effective July 1, 2018, the Town increased its rates to MECO from \$5.26 per 1,000 gallons to \$5.42 per 1,000 gallons for water usage and from \$10.04 per 1,000 gallons to \$10.34 per 1,000 gallons for sewer usage. The Town also increased the monthly base charge from \$136.93 to \$141.04 for water service and from \$136.93 to \$141.04 for sewer service.

MECO's current rates have been in effect since May 4, 2018, when they were approved by the Commission in its Order Granting Partial Rate Increase and Requiring Customer Notice issued in Docket No. W-1166, Sub 17.

MECO requested that it be allowed to increase its rates as shown below:

The Public Staff presented this matter at the Commission's Regular Staff Conference on July 30, 2018. The Public Staff stated that it had reviewed MECO's request and recommended that the tariff revision be approved as proposed by MECO.

Based upon the foregoing, the Commission finds that MECO should be allowed to pass through the costs associated with the increased purchased water and sewer expense.

IT IS, THEREFORE, ORDERED as follows:

- 1. That MECO Utilities, Inc., is granted a tariff revision as set forth herein.
- 2. That the Schedule of Rates, attached hereto as Appendix A, is approved and is deemed filed with the Commission pursuant to G.S. 62-138. This Schedule of Rates shall become effective for service rendered on and after the date of this Order.

FINDINGS OF FACT

- 1. Old North State presently holds water franchises serving approximately 406 customers and wastewater franchises serving approximately 2,643 customers in North Carolina. Old North State's record of service is satisfactory.
- 2. Old North State expects eventually to serve 201 wastewater customers in the first phase and eventually 400 wastewater customers at buildout in Stateside Subdivision. The service area is shown on plans filed with the application.

- 3. The North Carolina Department of Environmental Quality (NCDEQ), Division of Water Resources (DWR), Water Quality Permitting Section, has issued permit number WQ0035809, dated March 1, 2017, for the construction of the Stateside Wastewater Treatment Plant (Stateside WWTP). NCDEQ, DWR, Water Quality Permitting Section, has issued permit number WQ0038128, dated May 11, 2017, for the construction and operation of the Stateside Subdivision wastewater collection system.
- 4. Old North State has entered into an Agreement dated August 10, 2015 (Developer Agreement), with A. Sydes Construction, Inc. (Developer), under which Developer is installing the wastewater collection system and effluent infiltration ponds.

Old North State is requesting a connection fee of \$3,500 per SFRE for wastewater service, to be paid by the builder or person first requesting service to a particular lot. The Developer Agreement provides for Old North State to design and construct at its cost the WWTP at the approximate cost of \$1.6 million. The first 300 SFREs will pay connection fees being contributions in aid of construction totaling \$1,050,000. The Public Staff stated at the July 30, 2018 Commission Regular Staff Conference that in future general rate cases the Public Staff will evaluate whether to recommend an excess plant rate base adjustment for the Stateside WWTP. Old North State is purchasing the wastewater system for \$3,500 per SFRE from Developer, payable quarterly based upon the number of connections installed during the previous quarter. The purchase price payments shall begin with the 301st connection to the wastewater collection system.

- 5. Old North State has filed all exhibits required with the application.
- 6. Old North State has the technical, managerial, and financial capacity to provide water utility service in this franchise location.
- 7. The Public Staff has recommended that Old North State be required to post a \$10,000 bond for Stateside Subdivision. Old North State currently has \$600,000 of bonds posted with the Commission. Of this amount, \$440,000 of bond surety is assigned to specific subdivisions, and \$160,000 of bond surety is unassigned.

CONCLUSIONS
