NOW COME THE PUBLIC STAFF – North Carolina Utilities Commission (Public Staff), by and through its Executive Director, Christopher J. Ayers, and Old North State Water Company, Inc. (ONSWC), and file an update on the requirements of Ordering Paragraph No. 8 of the Order Approving Settlement Agreement and Stipulation, Granting Partial Rate Increase, and Requiring Customer Notice (Rate Case Order) entered in this docket on June 13, 2022.

1. Ordering Paragraph No. 8 of the Rate Case Order requires ONSWC and the Public Staff (collectively, the Parties) to “continue to work together on how the uncollected income tax gross-up should be treated in ONSWC's accounting system to ensure that ratepayers are not negatively impacted in this rate case proceeding or future rate case proceedings” and “update the Commission on their efforts within 90 days of this Order.”

2. ONSWC and the Public Staff are continuing to work on the issue with the goal of arriving at a mutually agreeable solution by the next deadline set forth in Ordering Paragraph 8 of the Rate Case Order.

WHEREFORE, the Public Staff and ONSWC request that the Commission accept this filing in compliance with the 90-day reporting requirement of Ordering Paragraph No. 8 of its Order Approving Settlement Agreement and Stipulation, Granting Partial Rate Increase, and Requiring Customer Notice issued in this docket on June 13, 2022.
