In accordance with the North Carolina Utilities Commission's ("Commission") *Order Granting Extension of Time to File Witness List*, Public Service Company of North Carolina, Inc. d/b/a Dominion Energy North Carolina ("PSNC") hereby notifies the Commission that the only party that intends to cross-examine witnesses is the Attorney General's Office. The Attorney General's Office intends to cross-examine PSNC witness Michael B. Phibbs for 15 minutes and PSNC witness Byron W. Hinson for 15 minutes.

PSNC, the Public Staff, Carolina Utility Customers Association, Inc., and Evergreen Packaging, LLC have reached a settlement in principle, and a stipulation of settlement and supporting testimony and exhibits will be filed. The stipulating parties plan to request that all witnesses except for those being cross-examined by the Attorney General's Office or sponsoring testimony in support of the forthcoming stipulation of settlement be excused.
