# SETTLEMENT TESTIMONY OF JOSIAH COX ON BEHALF OF RED BIRD UTILITY OPERATING COMPANY, LLC

- 1 Q. PLEASE STATE YOUR NAME AND BUSINESS ADDRESS.
- 2 A. My name is Josiah Cox. My business address is 1630 Des Peres Road, Suite 140,
- 3 St. Louis, Missouri, 63131.
- 4 Q. ARE YOU THE SAME JOSIAH COX WHO PREVIOUSLY FILED
- 5 **DIRECT TESTIMONY IN THIS DOCKET?**
- 6 A. Yes.
- 7 Q. WHAT IS THE PURPOSE OF YOUR SETTLEMENT TESTIMONY?
- 8 A. The purpose of my settlement testimony is to support the Settlement Agreement
- 9 and Stipulation ("Stipulation") entered into by the Public Staff and Red Bird Utility
- Operating Company, LLC ("Red Bird" or the "Company") (collectively, the
- "Stipulating Parties") on March 21, 2024.

# 1 Q. DOES THE STIPULATION RESOLVE ALL ISSUES IN THIS

#### 2 **PROCEEDING?**

- 3 A. Yes. The Stipulation resolves all issues in this proceeding, including the rate base
- in the utility assets Red Bird proposes to acquire from A&D Water Services, Inc.
- 5 ("A&D"), the extent of Red Bird's due diligence costs, the rates Red Bird will
- 6 charge following the acquisition, and whether Red Bird will seek an acquisition
- 7 adjustment in this or any future proceeding.

#### 8 Q. HOW DOES THE STIPULATION RESOLVE ALL OF THOSE ISSUES?

- 9 A. The Stipulation reflects the Stipulating Parties agreement that Red Bird be entitled 10 to an acquisition adjustment relating to the acquisition of the High Vista wastewater 11 system, establishes the net book value of the A&D water and wastewater system 12 assets to be acquired by Red Bird, and provides for Red Bird's recovery of a portion 13 of its due diligence and transactional costs relating to this acquisition. The 14 Stipulation also establishes that Red Bird will adopt the proposed tariffs and rates 15 currently in effect for the Buffalo Meadows, Camelot, Cinnamon Woods, High 16 Vista, Hunters Glen, Kirk Glen, Mountain Valley, Rolling Oaks Estates, Sherwood 17 Forest, Skyview Park, and White Oak Village subdivisions.
- 18 Q. DOES RED BIRD BELIEVE THE STIPULATION IS A REASONABLE
  19 RESOLUTION OF THE ISSUES IN THIS PROCEEDING?
- 20 A. Yes. The Company believes the Stipulation reflects a fair, just, and reasonable 21 resolution of the issues it addresses. The Stipulation is the result of arms-length 22 negotiations between the Stipulating Parties and resolves all of the issues in this

## Q. ARE THERE OTHER BENEFITS TO COMMISSION APPROVAL OF THE

## 4 STIPULATION?

A.

Yes. We anticipate that the Stipulation will facilitate an earlier closing of this acquisition, thereby allow Red Bird to begin operating these systems, and bringing the benefits of its ownership of these systems to A&D's customers earlier than would otherwise be possible. This is especially important where, as here, several of the A&D systems in this proceeding are not in compliance with applicable health, safety, and environmental protection laws and regulations.

In addition, Red Bird has other transfer applications pending before the Commission, and we look forward to adding the A&D systems to the portfolio of systems the Company seeks to improve in North Carolina. Red Bird is part of an affiliate group that currently owns and operates wastewater systems serving approximately 241,000 wastewater customers and drinking water systems serving approximately 172,000 customers in Missouri, Arkansas, Kentucky, Louisiana, Texas, Tennessee, Mississippi, Florida, South Carolina, North Carolina, and Arizona. As we move forward with our business model and plans in North Carolina, we will continue to work to replicate the record of success our affiliate group has achieved elsewhere.

Finally, as shown in my direct testimony, Red Bird has the financial, technical, and managerial ability to acquire, own, and operate the A&D water and wastewater systems in a manner that achieves compliance with applicable health,

- safety, and environmental protection laws and regulations, and provides reliable,
- 2 safe, and adequate service to all of A&D's customers.
- 3 Q. DOES THIS CONCLUDE YOUR SETTLEMENT TESTIMONY?
- 4 A. Yes.
