I don't know if you are aware of what's happening to our utility bills but let me tell you about my most recent from Piedmont Natural Gas for the period Jan 2021 to Jan 2022. During winter months I keep my thermostat on 71, 24-7.

According to their bill the Avg Temp was 42 for both periods, however, the former period shown was for 35 days and the current period 29 days, I guess to distort the comparison. But on a per therm basis, the utilities commission has given them a $\mathbf{2 2 . 7 \%}$ increase from last year!!!

If the job of the North Carolina Utilities Commission is to regulate rates somebody has really dropped the ball. As a reminder to the Commission, I don't have a choice if I want to heat my home. It's given to me on a "take it or leave it" basis.

A January 21, 2022 article from Natural Gas Intelligence stated "NATURAL GAS PRICES FORECAST TO HOLD STEADY IN 2022" and noted, "Henry Hub spot prices averaged \$3.91/MMBtu for 2021, the EIA noted in the most recent Short-Term Energy Outlook. This year and 2023 should bring slightly lower pricing for the national benchmark, with average prices of $\$ 3.79$ for 2022 and $\$ 3.63$ next year."
