NOW COMES THE PUBLIC STAFF - North Carolina Utilities Commission (Public Staff), by and through its Chief Counsel, David Drooz, and moves that the Commission issue an order granting the Public Staff and Intervenors additional time to file testimony in the above-captioned docket. In support of this Motion, the Public Staff respectfully shows unto the Commission:

- 1. On April 26, 2017, the Commission declared the above-captioned docket a general rate case and suspended rates. By Order dated June 2, 2017, the Commission scheduled hearings, and required customer notice.
- 2. The Commission Order specified that the Public Staff and Intervenors should pre-file testimony on or before August 31, 2017, and provided that the Applicant should file rebuttal testimony no later than September 13, 2017.
- 3. On August 30, 2017, the Public Staff filed a motion requesting that the Commission grant additional time for the Public Staff and Intervenors to prefile testimony until September 12, 2017, and for the Applicant to file rebuttal

testimony until September 15, 2017. The Commission granted the Public Staff's Motion by Order dated September 1, 2017.

- 4. The Public Staff and CWSNC have reached settlement of all issues in dispute, but need additional time for the Company to provide information regarding final capital projects that it seeks to include in the case and to allow the Public Staff time to audit those projects.
 - 5. All parties consent to this Motion.

THEREFORE, the Public Staff requests that the Commission approve an extension of time to September 19, 2017 for the Public Staff and CWSNC to file a stipulation and settlement agreement and supporting pre-filed testimony in this docket.
