Pursuant to the Order Scheduling Hearing, Establishing Discovery Guidelines, And Requiring Customer Notice issued in these dockets on July 11, 2023 (“Scheduling Order”), Red Bird Utility Operating Company, LLC (“Red Bird”) consulted with all other parties and it now files this list of witnesses to be called at the hearing, the order of witnesses, and the estimated time for cross-examination.

On September 19, 2023, Public Staff filed the Testimony of Lynn Feasel, Evan Houser, and John Hinton.


On October 13, 2023, Red Bird filed the Rebuttal Testimony of Todd Thomas and Caitlin O’Reilly.


