Pursuant to the North Carolina Utilities Commission's November 18, 2022, Order in Docket No. G-9, Sub 698 and other related dockets, including Docket No. G-9, Sub 810, Cardinal Bio Energy, LLC ("Cardinal") hereby submits the following biannual status report regarding the renewable natural gas project that Cardinal is developing in and around Maxton and Laurinburg, North Carolina (hereinafter the "Laurinburg Project").

RESPONSES.

Answer: The Laurinburg Project is presently in the design phase. It is anticipated that 100% of the source material will be will be injected annually at the interconnection location with no more than approximately

The finished RNG production pressure will be boosted at the interconnection point to exceed the pipeline pressure at that location but will not exceed Piedmont Natural Gas Company, Inc.'s established Maximum Allowable Operating Pressure (MAOP).

2. Number of farms and other sources of biogas.

<u>Answer:</u> To date, Cardinal has not entered into a supply contract with any farm or other source of biogas.

3. Disposition of RNG placed on Piedmont's distribution system.

Answer: Cardinal intends to sell all of the RNG placed on Piedmont's distribution system to one third-party entity who intends to sell the RNG in accordance with Piedmont's requirements.

4. Status of RIA with Piedmont.

Answer: The RIA between_Cardinal and Piedmont was executed on 11/10/2022 and approved by the Commission on 1/20/23.

5. Construction Status.

<u>Answer:</u> The project is in the design phase which, when completed, will be followed by a preliminary engineering phase.

6. Estimated date for commercial operation.

Answer: Subject to modifications or alterations necessitated by the on-going development and engineering phases, Cardinal anticipates a commercial operations date in or around
