Dear Ms. Morris:

NTE Carolinas II, LLC, ("NTE"), through its undersigned counsel, hereby notifies the Commission that it has entered into an option agreement to add approximately eighty (80) acres to the property on which it proposes to construct and operate a 500-MW combined cycle combustion turbine electric generation facility ("Facility") that is the subject of its CPCN application in Docket No. EMP-92, Sub 0 ("Application").

The location of this additional, contiguous property is indicated in yellow highlighting on the "AMENDED ATTACHMENT 4 - Project Site Map" enclosed herewith. This map should be considered as a replacement Project Site Map as part of "ATTACHMENT 4" to the Application for a Certificate of Convenience and Public Necessity filed in this docket on June 29, 2016 ("Application"). The purpose and utilization of this property will be solely as additional buffering and as a potential alternative for the access driveway to the Facility. NTE is not relocating, altering or otherwise modifying in any way the proposed Facility or its location as shown on "ATTACHMENT 5" to the Application. Other than a change in the amount of acreage to be owned by NTE for the Facility location, all other information in the Application and in the Testimony of Michael Green filed therewith is the same. (Rockingham County has indicated that this additional property and potential driveway relocation will not require an amendment to, or additional, Special Use Permit issued by the County as the local zoning approval of the Facility.)

NTE has modified the total acreage stated in the Public Notice being published by the Rockingham County Section of the Greensboro News and Record pursuant to paragraph 7 of the Commission's order in this docket dated August 16, 2016, and that notice, with the correct acreage, will be published once a week for four successive weeks, as required by that order. Therefore, the addition of this acreage does not affect the public notice or any of the dates set forth in the Scheduling Order. The schedule for the docket remains unchanged.

To the extent that the Commission determines that the addition of this property to the Facility location constitutes an amendment to the CPCN Application, NTE requests that the application be so amended, and attached to this letter is a Verification by Michael Green to ensure that any such amendment complies with the requirements of the Commission Rule R6–63.
