Dear Ms. Campbell:

On October 10, 2019, the North Carolina Utilities Commission issued its *Order on Interim GSA Program Implementation* in the above-captioned dockets ("Order"). In addition to approving Duke Energy Progress, LLC's ("DEP") and Duke Energy Carolinas, LLC's ("DEC") and together with DEP, the "Companies") proposed approach with respect to the interim implementation of the Green Source Advantage ("GSA") Program, the Order directed Duke to report to the Commission "the number of GSA Program applications that DEC and DEP received to date. . . the number of applications seeking each bill credit option. . . the number of applications received from customers in each of the categories of eligible customers (major military installations, the University of North Carolina, or the eligible nonresidential customers)."




