 - d. 235 and 243 Old Ferry Dock Road; and
 - e. 122 and 136 Mullens Drive.

> 2. Exhibit 10: Please file the onsite wastewater system design drawings and a permit for Cape Pointe Village. The May 4, 2016 service agreement letter between HISCO East, LLC and Academy Field (Cape Pointe Village Subdivision) states, "the Developer and its engineering firm just design and permit the onsite wastewater system, and required offsite sewer mains connecting Cape Pointe Village S/D to Harkers Village WWTP."

The Public Staff considers the CPCN Application incomplete as filed due to the above-listed deficiencies. The Applicant will need to file an Amended CPCN Application with the information described above with the Commission and provide the Public Staff with a copy of the filing. The Public Staff will resume its review upon the filing in the docket system of the same.
