P R O C E E D I N G S

HEARING EXAMINER JEFFRIES: Let's go on the record now. My name is Nicholas Jeffries. I am a Hearing Examiner with the North Carolina Utilities Commission, and I have been assigned to hear this case today. It is 10:05 a.m. on Friday, April 19th, 2024, and we are in the Commission Hearing Room 2115 in Raleigh, North Carolina.

I now call for hearing Docket Number T-4932, Sub 0, L.W. Wilson Moving & Trucking, LLC, hereinafter referred to as Respondent, or Wilson, of 2038 Maitland Drive, Fayetteville, North Carolina 28314, In The Matter of Revocation of Certificate of Exemption Number C-3048 for failure to attend the Commission required Maximum Rate Tariff training seminar no later than three months from the issuance of Respondent's Certificate of Exemption on May 30th, 2023.

The Commission's official file reflects that on April 10th, 2023, Respondent filed with the Commission an Application for a Certificate of Exemption.

On May 30th, 2023, the Commission issued an Order granting Application for a Certificate of Exemption, authorizing L.W. Wilson Moving & Trucking,

1 LLC, to transport household goods between all points
2 and places within North Carolina under Certificate of
3 Exemption Number C-3048. Among other things, the
4 Order requires that the Applicant shall attend an
5 online Maximum Rate Tariff training seminar no later
6 than three months from the date of this Order. May
7 30th, 2023 Order, Ordering Paragraph Number 5.

8 On December 7th, 2023, the Public Staff
9 notified Commission Staff that Wilson had not attended
10 any of the training seminars held since its
11 certification on May 30th, 2023.

12 On December 14th, 2023, Commission Staff
13 issued a certified letter addressed to Lee Wilson,
14 Jr., owner of L.W. Wilson Moving & Trucking, LLC,
15 notifying him that either he or a representative for
16 Wilson is required to attend the next scheduled MRT
17 training seminar or the Commission would have no other
18 option but to cancel Wilson's Certificate of
19 Exemption.

20 On February 6th, 2023, the Commission issued
21 an Order Suspending Certificate of Exemption for
22 Failure to Attend MRT seminar. Among other things,
23 the Order required Wilson to attend the next MRT
24 training seminar, which was scheduled to be held

1 online on February 29th, 2024, in order to prevent the
2 suspension of its Certificate of Exemption on March
3 1st, 2024. In the alternative, the Order also
4 required Wilsons' appearance before the Commission to
5 show why its Certificate of Exemption should not be
6 revoked for failure to comply with the Commission's
7 Orders.

8 On March 1st, 2024, Public Staff notified
9 Commission Staff that L.W. Wilson Moving & Trucking,
10 LLC, failed to attend the February 29th, 2024 MRT
11 training seminar.

12 On March 12th, 2024, the Commission issued
13 an Order requiring Wilson to appear before the
14 Commission on this day and at this time to show cause
15 why (a) its Certificate of Exemption should not be
16 revoked for willful failure to attend a mandatory MRT
17 training seminar as required by Ordering Paragraph
18 Number 5 of the May 30th, 2023 Order; and (b) it
19 should not be subject to such penalty under -- or
20 other sanctions as the Commission may impose pursuant
21 to North Carolina General Statute § 62-310.

22 Let the record reflect that Respondent is
23 not present nor is anyone present to appear on its
24 behalf. That being the case, the Commission will

1 issue the appropriate Order canceling the Respondent's
2 Certificate for willful failure to attend a mandatory
3 MRT training seminar as required by Ordering Paragraph
4 Number 5 of the May 30th, 2023 Order.

5 This hearing is adjourned.
