Red Bird Utility Operating Company, LLC ("Red Bird") provides this Clarification as to its Verified Report Regarding Issues Raised at Public Hearing filed on October 9, 2023. That Verified Report addressed customer service and service quality complaints described during the public witness hearing held on September 25, 2023. The following statement was included on page 7 of that Verified Report:

While the water for Lake Royale is supplied through an interconnection with Franklin County, it is Red Bird's understanding that the water tank is in poor condition and has been allowed to deteriorate for many years. The corrosion, rust, sediment accumulation, deteriorated components, and structural failures are all possible issues that have caused or contributed to the water quality issues reported by customers. Red Bird plans to work with Franklin County to identify its capacity to meet state storage requirements and either rehabilitate, replace, or remove the tank which the Company believes will clear up various quality issues experienced by customers.

Franklin County construed this statement as suggesting that the water tank at Lake Royale is owned by the County and has requested that Red Bird make a clarifying filing. The quoted statement was unartfully worded and could possibly be read to suggest the referenced water tank is owned by Franklin County. To correct any misunderstanding on this point, Red Bird hereby clarifies its Verified Report to make clear that the referenced water tank is owned by TESI, and that at closing that water tank and an associated pump will be transferred from TESI to Red Bird. After closing, Red Bird will be solely responsible for the operation, rehabilitation or replacement, and maintenance of that equipment.

**WHEREFORE**, Red Bird respectfully requests that the Commission accept this Clarification as to its previously filed Verified Report.
