**PUBLIC STAFF'S MOTION
FOR EXTENSION OF TIME**

NOW COMES THE PUBLIC STAFF – North Carolina Utilities Commission, by and through its Executive Director, Christopher J. Ayers, and respectfully requests the Commission to extend the time for filing comments in the above-captioned dockets to and including November 21, 2022. In support of this motion, the Public Staff shows as follows:

1. On August 15, 2022, Duke Energy Carolinas, LLC, and Duke Energy Progress (collectively, Duke or the Companies) filed a joint application seeking approval of the Companies' Electric Vehicle Supply Equipment (EVSE) Programs as standalone tariffs.

2. On August 23, 2022, the Commission issued an order requesting comments on the Companies' proposed customer operated EVSE tariffs. The Commission ordered that the Public Staff and other intervenors may file initial comments on Duke's proposed EVSE tariffs by September 21, 2022, and that all parties could file reply comments by October 5, 2022.

3. Due to the press of other business, and particularly in light of the Carbon Plan hearings in Docket No. E-100, Sub 179, the Public Staff requests an additional 60 days to file comments in these dockets, and a corresponding extension of the reply comments.

4. The Public Staff notes that the Companies did not propose an effective date, so the 60-day extension, if approved by the Commission, should not impede the implementation of the Pilot.

5. The Public Staff has conferred with Duke, which has no objection to this request for a 60-day extension of time.

THEREFORE, the Public Staff moves that the Commission grant an extension of time until the close of business on November 21, 2022, in which to file initial comments in these dockets, and a corresponding extension of time until the close of business on December 5, 2022, in which to file reply comments.
