RE: Mark Rodriguez is Seeking to Become Listed as a Utility Valuation Expert in NC

Dear Ms. Dunston:

I am respectfully seeking to become listed as a *Utility Valuation Expert* before the North Carolina Utility Commission as described within the proceeding in Docket No. W-100, Sub 60A. I have extensive experience as an impartial valuation expert in appraising public utility property including both water and wastewater assets. My application to the Commission furnishes the following requested information:

(1) A demonstration of the person's education and experience specific to providing valuations and appraisals of utility plant, as differentiated from other types of appraisals, such as for real estate;

In December 1999 in a basement of a small cape cod house in New Jersey with nothing more than a big entrepreneurial dream and a lot of hustle, **Mark Rodriguez**, **ASA MRICS** founded "MR Valuation Consulting, LLC." Mark Rodriguez will perform assignments with impartiality, objectivity, and independence, and without accommodation of personal interests. He will protect the confidential nature of the client relationship and comply with applicable privacy laws and regulations. In addition, he will not perform valuation work on a contingent basis.

(3) A demonstration of financial and technical fitness, such as through production of professional licenses, technical certifications, and names of current or past clients with a description of dates and types of services provided;

Mark Rodriguez is an "Accredited Senior Appraiser" with the American Society of Appraisers with a discipline in Machinery and Technical Specialties.

Mark Rodriguez is a "Chartered Valuation Surveyor" and Professional Member of The Royal Institution of Chartered Surveyors. This institution was founded in London in 1868 and received a royal charter in 1881 to "promote the usefulness of the profession for the public advantage in the United Kingdom and in other parts of the world."

In 2020, Mark Rodriguez presented to the California Water Association; California Public Utilities Commission; and California State Water Resource Control Board a webinar on valuing water utilities in California.

Illinois (2004) – in the matter of Illinois American Water v. the City of Peoria, Illinois, Mark Rodriguez was appointed a "water industry valuation expert" and served as the third and impartial Commissioner. The Commission was charged by the court to determine the value of the water utility assets of the Peoria District Waterworks as the purchase price option for the potential acquisition by the City of Peoria. To be elected to this panel, there was an interview process of 10 highly qualified water utility valuation experts from around the country, including the big four accounting firms. Mr. Rodriguez excelled in the interview process and was elected by the court to serve as the third Commissioner.

- I, Mark Rodriguez, will make use of the assessment of the tangible assets of the system to be acquired, which assessment shall be from a Professional Engineer jointly retained by the utility and the Local Government Utility and make use of the Water and Wastewater Fair Value Engineering Assessment Form included in the Appendix to Chapter 7 and Chapter 10 of the Commission's Rules and Regulations.
- (6) A statement that the utility valuation expert will comply with the requirements of g.s. 62-133.1a in conducting their appraisal, including that the utility valuation expert shall appraise the subject property in compliance with the uniform standards of professional appraisal practice, employing cost, market, and income approaches to the assessment of value; and
- I, Mark Rodriguez, will comply with the requirements of G.S. 62-133.1A in conducting appraisals as a Utility Valuation Expert, including that the Utility Valuation Expert shall appraise the subject property in compliance with the Uniform Standards of Professional Appraisal Practice, employing cost, market, and income approaches to the assessment of value.
