NOW COMES Public Service Company of North Carolina, Inc. ("PSNC") and moves that the public witness hearing previously scheduled on this matter be canceled. In support of this motion PSNC respectfully shows unto the Commission:

- 1. This proceeding began with the filing of an Application for Rate Increase by PSNC on April 1, 2021.
- 2. By order issued on April 27, 2021, the Commission declared the proceeding to be a general rate case and suspended rates for up to 270 days.
- 3. By Order dated June 11, 2021, the Commission scheduled the matter for public witness hearings on Monday August 16, 2021, to be held remotely via Webex with the first session beginning at 1:30 p.m. and a second session beginning at 6:30 p.m. The Commission's Order further provided that "Only individuals registered with the Public Staff by 5:00 p.m. on Monday, August 9, 2021, will be allowed to testify at the hearings."

- 4. On July 15, 2021, PSNC filed a Certificate of Service attesting that all of its customers had been served with notice of the proposed rate increase and hearing.
- 5. The Company has been informed by the Public Staff that it did not receive any protests and no one registered to provide testimony at the public hearing by the deadline established in the customer notice.
- 6. The Company requests that the public hearings scheduled for Monday, August 16, 2021, be cancelled.
- 7. Counsel for the Public Staff North Carolina Utilities Commission (Public Staff) has authorized PSNC to state that the Public Staff does not oppose this motion.
 - 8. A proposed order is being filed with this motion.

WHEREFORE, PSNC requests:

- 1. That the Commission grant the request to cancel the public hearings scheduled at 1:30 p.m. and 6:30 p.m., on Monday, August 16, 2021, and
- 2. For such other and further relief as the Commission may deem just and proper.
