MOTION OF THE PUBLIC STAFF FOR ORDER TO SHOW CAUSE

NOW COMES THE PUBLIC STAFF-North Carolina Utilities Commission (Public Staff) by and through its Executive Director, Christopher Ayers, and moves the Commission to issue an order requiring KRJ, Inc., d/b/a KRJ Utilities (KRJ or Company) to show cause, if any there be, why it should not be required to pay penalties as authorized by N.C. Gen. Stat. §62-310(a) for its violations of the Commission's Order Approving Stipulation with a Condition, Granting Partial Rate Increase, and Requiring Customer Notice (Rate Case Order) issued on August 6, 2018. In support of this motion, the Public Staff states the following:

- 1. This proceeding commenced with the filing of an Application for Rate Increase by KRJ on January 10, 2018. A hearing was held before Commissioner Charlotte A. Mitchell, Presiding, Chairman Edward S. Finley, Jr., and Commissioner James G. Patterson.
- 2. Pursuant to the Rate Case Order, the Company was authorized to increase its rates partially, but decretal paragraph 14 required the Company to

"update the Commission on a quarterly basis concerning the status of the project to restore Well 2 in Southern Trace to increased pumping capacity. The first quarterly report shall be filed on or before October 15, 2018, for the quarter ending September 30, 2018. Such quarterly reporting shall continue until the actual project completion date has been reported by KRJ."

- 3. On June 13, 2022, Ms. Gina Holt, Public Staff Attorney, emailed Public Staff Engineering Data Request No. 8 (EDR 8) to Mr. James (Rod) Butler, former Vice President of Management Group of NC, Inc. and Contract Manager of KRJ, who had filed the previous quarterly reports of KRJ. EDR 8 was prepared by Mr. Charles Junis, Director of the Public Staff's Water, Sewer and Telephone Division.
- 4. On June 20, 2022, KRJ refiled the quarterly report filed on May 13, 2022.
- 5. By cover letter dated June 22, 2022, Mr. Butler sent responses to EDR 8.
  - 6. On July 11, 2022, KRJ filed a quarterly report on the utility's progress.
- 7. On October 17, 2022, KRJ filed its most recent quarterly report. The report was prepared by Mr. John Wiley Johnson, PE, Contract Manager of KRJ Utilities.
- 8. On October 22, 2022, Mr. Rod Butler sent the Commission and Public Staff an email via the Clerk's Office stating that he had managed the KRJ

utility for over 20 years and had resigned from his management position he and his company would end its management agreement with KRJ, effective the end of 2022. Mr. Butler further stated that "KRJ is in a transitional phase as they obtain replacement personnel/contractor to perform the duties that I/we have. In order to facilitate their transition, it is necessary that the contact data for KRJ, Inc be changed in the Commission and Public Staff's records to Mr. Robert Stafford the President of KRJ. See Exhibit 1.

- 9. On June 16, 2023, Mr. Junis called Mr. Robert Stafford, owner of KRJ and left a message informing Mr. Stafford of the delinquent report and requesting that the Company file the report as soon as possible. Mr. Junis did not receive a return call.
- 10. On August 18, 2023, Mr. Junis sent an email to Mr. Stafford requesting that he file the missing quarterly reports for information from October 14, 2022 and through at least June 30, 2023 by not later than August 31, 2023. See Exhibit 2. The Public Staff did not receive a response to this outreach.
- 11. The Public Staff then contacted Mr. Robert Bennink, the attorney listed on the service list for KRJ and inquired as to who should be contacted regarding the delinquent reports, and he referred the Public Staff to Mr. John Wiley Johnson, PE, Contract Manager of KRJ Utilities.
- 12. On September 20, 2023, Mr. Charles Junis emailed Mr. Johnson regarding the delinquent filings, and on October 4, 2023, Mr. Johnson responded to Mr. Junis stating that, "I had understood that KRJ had retained someone to

prepare the Public Staff documents but now I understand that those documents are for the utility rates. I will make an effort to respond ASAP." See Exhibit 2.

- 13. As of the date of this filing, KRJ has now failed to provide six quarterly reports since its last filing on October 17, 2022.
- 14. The Public Staff has been in communication with the North Carolina Department of Environmental Quality, Division of Water Resources, Public Water Supply Section (PWSS) regarding compliance and whether KRJ has sought approval of the new Well #4. The Public Staff understands that PWSS is experiencing similar reporting and responsiveness issues with KRJ.
- 15. The Public Staff believes that KRJ still has not restored the pumping capacity from Well #2 and is concerned about the status of service quality and reliability to KRJ's customers. The Public Staff took into consideration the transition period from the Companay's long-time manager to new management; however, the transition occurred more than a year ago and after several requests and reminders, the Company still disregards its responsibility to comply with the Commission's order.
- 16. Under N.C. Gen. Stat.§ 62-310(a) the Commission is authorized to impose a penalty of up to \$1,000 per day for each violation of its orders.

## WHEREFORE, the Public Staff prays:

1. That the Commission order the Company to appear and show cause why a substantial penalty, amounting to at least \$1,000 per day, should

not be imposed for the violations of the Rate Case Order issued on August 6, 2018, set forth above;

- 2. That the Commission order the Company to file the delinquent quarterly reports, or a cumulative update for the delinquent period, and then continue to file quarterly until otherwise ordered;
- 3. That the Commission order the Company to comply with Commission Rule R7-7 by taking reasonable and prudent actions in a timely manner; and,
- 4. For such other and further relief as the Commission may deem just and proper.

Currently, we are proceeding the permit submittals for the new additional Well 4 connection to existing Well 2, and the easement acquisitions for new Well 5 (which will connect to existing Well 3 and Well 6 which will stand alone.

We found that the suppliers of these small units of greensand filters and IX equipment have been acquired or out of business and our preferred contractor, Sylena Lowry was overloaded with similar projects.

Fortunately, Sylena now is available to start work on the system needed for Well 1.
