ORDER EXCUSING VOTE SOLAR  
WITNESSES FROM TESTIFYING  
AT EXPERT WITNESS HEARINGS

BY THE COMMISSION: On July 9, 2020, the Commission issued an Order Accepting Recommended Consolidated Issues for Remote Expert Witness Hearing and Postponing Separate Issue Hearings (Consolidated Hearing Order). The Consolidated Hearing Order identified the topics to be addressed by expert witness testimony in the

consolidated hearing in the above-captioned dockets involving general rate case applications by Duke Energy Carolinas, LLC (DEC), and Duke Energy Progress, LLC (DEP). Further, the Consolidated Hearing Order confirmed that the consolidated hearing will be held remotely beginning on July 27, 2020, but postponed the previously scheduled separate hearings on DEC's and DEP's applications until a date certain to be set by subsequent order.

On July 13, 2020, Vote Solar filed a Motion to Excuse Witnesses. In summary, Vote Solar stated that it has entered into Agreements of Settlement and Stipulation (Stipulations) with DEC and DEP resolving the contested issues between Vote Solar and the Companies on the Companies' proposed Grid Improvement Plan (GIP). Further, Vote Solar stated that as part of the Stipulations Vote Solar agreed to waive cross-examination on issues related to the GIP, and to seek to have its witnesses, James Van Nostrand and Tyler Fitch, excused from attending the expert witness hearings. Finally, Vote Solar stated that witnesses Van Nostrand and Fitch are designated to appear solely in the consolidated portion of the expert witness hearing to testify about the GIP.

On July 16, 2020, Vote Solar filed an amendment to its motion. Vote Solar stated that it had consulted with all parties regarding its motion, and that all parties have affirmatively waived the right to cross-examine witnesses Van Nostrand and Fitch.


Based on Vote Solar's motion and the records in these dockets, the Commission finds good cause to excuse witnesses Van Nostrand and Fitch from testifying at the consolidated expert witness hearing in these dockets to be held beginning July 27, 2020, and from testifying at the separate DEC and DEP hearings to be scheduled. Further, the Commission finds good cause to admit into evidence at the consolidated hearing the testimony and exhibits of witnesses Van Nostrand and Fitch.

IT IS, THEREFORE, SO ORDERED.
