Thank you for your reply.

The 7/29/15 email message from Allan Galvez to Maxine McLamb, which was filed with the Chief Clerk's Office in Docket No. ER-39, Sub 2, indicates that Conservice, on behalf of the applicant, is making "an official request to cancel the docket of ER-39". If the ER-39 dockets are not to be closed, Conservice will need to notify the Commission.

Also, the email states that Conservice is "no longer billing for electricity services at this property (Aspen Charlotte) as of 07/28/15". An appropriate filing will, therefore, need to be made in Docket Nos. ER-39, Sub 1 and ER-55, Sub 0, to amend the transfer application to reflect that fact (new billing agreement, billing statement, contact information, etc.).
