NOW COMES the North Carolina Clean Energy Business Alliance (“NCCEBA”), by and through counsel and pursuant to Rules R1-7 and R1-9 of the Rules and Regulations of the North Carolina Utilities Commission (“Commission”), and moves the Commission for a thirty-day (30) extension of time to file initial comments to Duke Energy Carolinas, LLC and Duke Energy Progress, LLC’s (together, “Duke”) proposed Requirements for Avoidance of the Solar Integration Services Charge (“SISC”) filed in this docket on November 18, 2019..

In support of this Motion, NCCEBA shows the Commission the following:

1. On November 18, 2019, Duke filed its proposed Requirements for Avoidance of the SISC.
2. On May 12, 2020, the Commission issued its *Order Requesting Comments on Proposed Requirements for Avoidance of SISC*, in which the Commission stated that parties may file initial comments addressing Duke’s proposed Requirements for Avoidance of SISC on before June 12, 2020.


3. NCCEBA is in the process of considering Duke's proposed Requirements for Avoidance of SISC and needs additional time to evaluate the technical information. As such, NCCEBA requests a thirty-day (30) extension for parties to file initial comments.

4. Duke supports NCCEBA's request for a thirty-day (30) extension of time, and the North Carolina Sustainable Energy Association, the Southern Environmental Law Center, and the Public Staff have indicated that they do not oppose NCCEBA's request for a thirty-day (30) extension of time.

WHEREFORE, NCCEBA respectfully requests that the Commission grant a thirty-day extension of time so that NCCEBA and other parties may file initial comments on or before July 12, 2020.


