NOW COME Public Service Company of North Carolina, Inc., d/b/a Dominion Energy North Carolina (“PSNC”), and the Public Staff—North Carolina Utilities Commission (“Public Staff”) and together with PSNC, (“Movants”) pursuant to Rule R1-7 of the Rules and Regulations of the North Carolina Utilities Commission (“Commission”), and move the Commission for a seven-day extension of time through and including October 11, 2021, for Movants to file proposed orders and/or briefs.

In support of the foregoing, Movants show as follows:

1. A public hearing was held on this matter on August 10, 2021 pursuant to the Commission’s *Order Scheduling Hearing, Requiring Filing of Testimony, Establishing Discovery Guidelines and Requiring Public Notice*. At the hearing, Commissioner Brown-Bland ruled that proposed orders and/or briefs shall be filed 30 days after the transcript of the evidentiary hearing is made available.

2. On September 2, 2021, the Commission issued a *Notice of Due Date for Proposed Orders and/or Briefs*, stating that proposed orders and/or briefs are due to be filed no later than October 4, 2021, pursuant to Commissioner Brown-Bland’s ruling at the evidentiary hearing.

3. Movants are working diligently to prepare their proposed orders and/or briefs; however, due to the press of other business, Movants require additional time to finalize their proposed orders and/or briefs.

4. Based on the foregoing, Movants request an extension of seven days, up to and including October 11, 2021, for all parties to file the proposed orders and/or briefs.

5. The requested extension will not result in prejudice to any party.

6. Counsel for Movants has contacted counsel for Haw River Assembly regarding this Motion, and they have advised that they do not object to the Motion.

WHEREFORE, Public Service Company of North Carolina, Inc. and the Public Staff respectfully request that the Commission grant this Motion for an extension of time through and including October 11, 2021 to file proposed orders and/or brief in this proceeding, and grant such other relief as the Commission deems just and proper.
