Subj: Motions to Compel Duke Energy Progress (DEP) for Needed Information/Documents Pertaining to Docket No. E-2, Sub 1150 and Commission "Order" to Grant Certificate for Route 31; Below are Motions:

- 1. These Motions are not frivolous. Intervener is aware 1., 2. and 3. are similar, but are different General Statutes requiring on/about same information. Reply from all three will be compared to Hearing Transcript of 31 Oct. 2017, as this is benchmark for Uncontroverted Evidence.
- 2. In accordance with (IAW) reference (a), Motions to Compel are submitted:
- a. Motion to Compel DEP furnish compliance with G.S. 62-2(4a) for the "Cost Comparison of the Four Best-Scored Alternative Routes"; ",as pertains to, in accordance with (IAW), "lower cost of new facilities and lower rates over the operating lives of such new facilities".... (I refer to this cost as Life-Cycle Cost; CT. gives 40 years as a Life-Cycle Cost. DEP may give a 230kV transmission line a Life-Cycle Cost in years such as, example: 40, 50, 60, 75 years, etc.; what is requested: Cost of construction all four lines, (submitted as suspect new evidence) and the Cost of Operation and Maintenance of all four lines for a comparison via Life-Cycle Cost for comparison.)
- b. Motion to Compel DEP furnish Compliance with G.S. 62-102(a), (4), c. "Alternatives to proposed action." --to include Cost of Construction, Operation, and Maintenance.
- c. Motion to Compel DEP furnish Compliance with G.S. 62-105. Burden of Proof, decision.
- (a)"...-The Commission shall Grant a certificate for the construction, operation, and maintenance of the

proposed transmission line if it finds: (3) That the cost associated with the proposed transmission line are reasonable;"

- d. Motion to Compel DEP furnish the authorization document, (written or spoken by whom) to enter into Record, the "Cost Comparison of the Four Best Scored Alternative Routes" as a Late-Filed Exhibit No. 2 under the cover letter by DEP of 13 Nov. 2017; signed by Lawrence B. Somers. (This looks like New Evidence unauthorized, entered into Record. Per the Hearing Transcript of 31 Oct. 2017, this cost comparison information was not in DEP's application 14 Jul. 2017 or update of 24 Jul. 2017, nor it was not authorized during the Hearing via the Transcript.) -Therefore, this must be investigated for the record, to establish place in Record.
- e. Motion to Compel DEP furnish a scaled map of the area concerning four best-scored alternative routes: Route 31, Route 4, Route 32, and Route 1; with names of roads, creeks, branches, landmarks for reference points so I can drive to the places. (DEP furnished a fairly good map for the Clayton area shown in DEP Application, page -104/179, shows on/about (o/a) 35 roads and reference points so you could follow proposed routes.) The map for area requested is very poor for finding/knowing where a location of a route goes; reason for request. I still do not know exact (want to be close) where Route 31 and Route 4 runs, and I plan to drive both routes in N.C. in late June and July 2018.
