Dear Ms. Jarvis:

On Jul 28, 2017, Appalachian State University, d/b/a New River Light and Power Company (the “Petitioner”), initiated proceedings in this Docket by filing its Application for Adjustment to Rates and Charges Applicable to Electric Service In North Carolina. On August 14, 2017, Petitioner filed the Second Amendment To Application to Adjust Retail Rates (the “Second Amendment”), pursuant to which Petitioner requested the approval of nine (9) rate schedules submitted with the Second Amendment. On October 18, 2017, Petitioner filed revised rate schedules (Schedules LEDL, OL, R and G ) for four (4) of the rate schedules previously filed with the Second Amendment,. On October 31, 2017, in connection with Supplemental Testimony filed by witnesses Halley and Brown, Petitioner filed five (5) filed further revised rate schedules, Schedules A, R, G, GL and GLH.

Inasmuch as the further revised Rate Schedules A.R. G, GL and GLH, filed on October 31, 2017, proposed rates slightly higher than the rates submitted with the Second Amendment, as amended on October 18, 2017, and slightly higher than the proposed rates set forth in Petitioner’s Notice To Customers, published in The Watauga Democrat on September 10 and September 17, 2017, pursuant to the Order of the North Carolina Utilities Commission (the “Commission”) dated August 28, 2017, Petitioner hereby withdraws revised rate schedules A, R, G, GL, and GLH, filed on October 31, 2017, and
