2 HEARING EXAMINER FENNEL: Good morning.  
3 Let's come to order and go on the record. I'm Heather  
4 Fennell, Staff Attorney for the Utilities Commission,  
5 and the Hearing Examiner for this proceeding.

6 I now call for hearing Docket Number E-22,  
7 Sub 588, which is the Application by Dominion Energy  
8 North Carolina for Approval of Renewable Energy and  
9 Energy Efficiency Portfolio Standard Cost Recovery  
10 Rider Pursuant to North Carolina General Statute  
11 § 62-133.8 and Commission Rule R8-67.

12 On August 11, 2020, Dominion Energy North
