I'm Charlotte 4 Mitchell, Chair of the Utilities Commission. 5 I now call for hearing Docket G-41, Sub 55, 6 In the Matter of the Application of Toccoa Natural Gas 7 for an Annual Review of Its Gas Costs Pursuant to North Carolina G.S. § 62-133.4(c) and Commission Rule 8 9 R1-17(k)(6). On September 1st, 2020, Toccoa Natural Gas 10 submitted the testimony and exhibits of witnesses 11 12 Harry Scott and Rai Trippe attesting to the prudency 13 of Toccoa's gas costs during the review period and the 14 propriety of its accounting for such costs. 15 On September 8th, the Commission issued an 16 Order Scheduling Hearings, Requiring the Filing of 17 Testimony, Establishing Discovery Guidelines and 18 Requiring Public Notice. 19 Intervention and participation in this 20 docket by the Public Staff is made and recognized 21 pursuant to Statute. 22 On October 20th, 2020, the Public Staff 23 filed the joint testimony of witnesses Naba and 24 Morgan.

Also, on October 20th, Toccoa filed a motion 1 2 to excuse the appearances of witnesses at the expert 3 witness hearing and to allow the introduction of all 4 prefiled testimony and exhibits into the record. 5 On October 26th, the Commission issued its 6 Order Excusing Expert Witnesses, Accepting Testimony 7 and Exhibits and Canceling the Expert Witness Hearing. 8 That brings us to this morning. We are here 9 this morning for the public witness portion of this 10 hearing. Please let the record reflect that there are 11 no public witnesses present in the room to provide 12 testimony.
