CCEBA was allowed to intervene and participated in the prior proceedings related to Resource Planning and Carbon Plan process, including E-100, Sub 165 (2020 IRP) and E-100, Sub 179 (2022 Carbon Plan) and was actively involved in the negotiations leading to the enactment of House Bill 951 ("HB 951") under which the Carbon Plan was developed.

4. As an active Carbon Plan docket participant and a participant in the stakeholder process preceding the filing of the current Carbon Plan / Integrated Resource Plan, CCEBA has information and expertise relevant to the concerns of the renewable energy industry and its customers which should be considered in these rulemaking implementation discussions.




