North Carolina Interconnection Procedures
Annual Interconnection Requests and Fee Revenue Report
Docket No. E-100, Sub 101

Dear Ms. Dunston:

Pursuant to Ordering Paragraph 3 of the North Carolina Utilities Commission's ("Commission") June 14, 2019 *Order Approving Revised Interconnection Standard and Requiring Reports and Testimony* ("2019 Order"), Virginia Electric and Power Company, d/b/a Dominion Energy North Carolina ("DENC" or "the Company"), is providing its Annual Interconnection Requests and Fee Revenue Report for filing in the above-referenced proceeding.

Ordering Paragraph 3 of the 2019 Order requires the Utilities to file by March 1 of each year a "verified report showing interconnection-related expenses and revenues associated with fee-related work for the prior year." The Discussion and Conclusions related to this requirement is largely supported by testimony from the Duke Utilities and further clarifies that the report should include "the volume of Interconnection Requests received, the amount of fees collected pursuant to the NC Interconnection Standard, and the Duke Utilities' actual expenses incurred for interconnection-related work." 2019 Order at 17. The Order also requires the Utilities to include information regarding the number of post-commissioning and periodic inspections conducted each year. 2019 Order at 21.

The relevant information for DENC for calendar year 2023 is:

- Interconnection Requests, including net metering, received: 112 (110 were fee-based)
- Fee Revenue received: \$24,250
- Post-commissioning and periodic inspections conducted: 0

Additionally, Ordering Paragraph 3 of the Commission's March 6, 2023 Order Requesting Periodic Reporting Regarding Comprehensive Compliance with NCIP Section 6.5 ("2023 Order") directed the Utilities to file the following information within 60 days of the Order, and then annually with the Annual Interconnection Requests and Fee Revenue Report beginning in 2024:

- a list of all activities undertaken to maintain compliance with NCIP Sections 6.5.2, 6.5.3, and 6.5.4;
- the status of all plans and programs associated with NCIP Section 6.5.2, if any, along with an updated timeline for planned completion of inspection of the total population of Uninspected Facilities, if any; and
- the status of any and all plans and programs associated with NCIP Section 6.5.3, along with a description of the inspection program(s), inspection cycles, and other pertinent information.

Accordingly, DENC submits the following information for consideration. During calendar year 2023, DENC did not perform any post-commissioning or periodic inspections under NCIP Sections 6.5.2, 6.5.3, and 6.5.4. As explained in its May 26, 2022 Comments filed in Docket E-100, Sub 101R and as supported by page 3 of the 2023 Order, DENC interprets NCIP Sections 6.5.2, 6.5.3, and 6.5.4 as providing the Utilities with discretionary authority to inspect the medium voltage AC side of any generating facilities interconnected to DENC's electric system. While DENC recognizes and reserves the right to implement a medium voltage inspection program in the future as described in Sections 6.5.2, 6.5.3, and 6.5.4, DENC currently utilizes the processes set forth in Articles 1 and 3 of the Interconnection Agreement as its primary methods of addressing the impact to the grid from an interconnected generating facility's medium voltage facilities. DENC believes this approach appropriately balances DENC's obligation to effectively protect DENC's electric system while treating all interconnection customers equally.
