Dear Ms. Dunston:

Pursuant to Sections 3.23 and 9.03 of Duke Energy Carolinas, LLC's ("DEC") and Duke Energy Progress, LLC's ("DEP," and together with DEC, the "Companies") Indenture associated with the Storm Recovery Bonds<sup>1</sup>, the Companies hereby provide notification to the North Carolina Utilities Commission ("Commission") of a proposed Amendment No. 1 to the Companies' Amended and Restated Intercreditor Agreement. The proposed Amendment No. 1 to the Amended and Restated Intercreditor Agreement is necessary to make ministerial changes to the agreement, including adding reference to a new bank account. Prior to making this filing, the Companies provided a confidential copy of Amendment No. 1 to the Commission and Public Staff—North Carolina Utilities Commission through the Bond Advisory Team communication process.

In accordance with Section 9.03 of the Indenture, the Companies also hereby provide the Commission a verified Officer's certificate stating that the proposed Amendment No. 1 to the Amended and Restated Intercreditor Agreement has been approved by all parties to the Indenture. The Officer's certificate is being provided through the Affidavit of Karl W. Newlin attached hereto.

The Companies request the Commission issue an order not objecting to the proposed Amendment No. 1 within fifteen (15) days of receipt of this notification, on or before July 31, 2023. Should the Commission have a response to the proposed Amendment
