Public Service Company of North Carolina, Inc., d/b/a Dominion Energy North Carolina ("PSNC"), hereby notifies the North Carolina Utilities Commission (the "Commission) of its joining the stipulation in the above-referenced dockets.

On October 26, 2021, Cardinal Pipeline Company, LLC ("Cardinal") filed a Depreciation Rate Study in Docket No. G-39, Sub 46 ("Sub 46 2021 Depreciation Rate Study Docket"). On March 15, 2022, Cardinal filed its general rate case application in Docket No. G-39, Sub 47 ("Sub 47 Rate Case Docket"), to adjust its rates and charges for natural gas service.

On March 28, 2022, the Public Staff filed a motion to consolidate Cardinal's Sub 46 2021 Depreciation Rate Study Docket and Sub 47 Rate Case Docket, which was granted by Commission Order dated April 4, 2022.
