Hello,

I'm a homeowner in the Brandywine Bay subdivision in Morehead City, NC. I will not be able to attend the hearing that is planned for 28 August in New Bern; however, I understand that you are receiving comments via email on the topic of the current Carolina Water Service rate increase request.

I am opposed to the rate increase. Since we moved here in 2010, our water bills have increased from \$70 per month to more than double that amount; our average bill so far in 2018 is \$165 for a household of only two adults. July is normally our highest water usage month, as we have a vegetable garden that we water in our back yard. I checked our water bills from July over time. In 2011, it was \$110; in 2018 it was \$215.

Despite the high rates, we do not find that our water is superior quality. We must both soften our water and filter it to make it acceptable for drinking and cooking. When we wash our cars, we are left with terrible water spots.

In addition, I find that the method used for billing is questionable. We are charged an equal amount for water use and wastewater service. Given that we water our garden and wash our cars, it is clear that our sewer use is lower than our water consumption. How can this sewer charge be fairly assessed when it appears the sewer system usage is not measured?

I feel quite powerless in this situation; even if we reduce our water usage to try to lower our costs, Carolina Water Service continues to raise our rates to cover their apparently ballooning expenses. In summary, I believe that Carolina Water Service should be required to conduct an internal review of their expenditures and to reduce their operating costs, rather than once again raising rates for customers to reach their "authorized rate of return." Considering the reduced corporate tax rates currently in effect, it is unacceptable that Carolina Water Service is demanding more money from customers again.
