Pursuant to North Carolina General Statutes ("N.C. Gen. Stat.") § 84-4.1 and Rule R1-22 of the North Carolina Utilities Commission (the "Commission") Rules of Practice and Procedure, Molly Suda of Duke Energy Corporation respectfully requests the Commission to enter an order permitting her to practice *pro hac vice* before the Commission on behalf of Duke Energy Carolinas, LLC ("DEC") and Duke Energy Progress, LLC ("DEP" and collectively with DEC, the "Companies") in the above-captioned matter. In support of this motion, Ms. Suda alleges and shows the following.

- 1. The above-captioned matter is a regulatory proceeding before the Commission, governed by North Carolina public utility law.
- 2. DEC and DEP are limited liability companies, duly organized and existing under the laws of the State of North Carolina, and are public utilities under the laws of North Carolina with operations subject to the jurisdiction of this Commission.
- 3. Ms. Suda is an attorney in good standing, licensed to practice law in the District of Columbia, and she will appear on behalf of the Companies in the above-captioned proceeding.

personally made on Ms. Suda.

- 9. Ms. Suda has not been disciplined by any court or lawyer regulatory organization, nor has she had *pro hac vice* privileges revoked.
- 10. The Statements required by N.C. Gen. Stat. § 84-4.1 are attached to this motion.
- 11. Upon issuance of an order granting this motion, the appropriate filings and fees will be made to the State Treasurer for support of the General Court of Justice and to the North Carolina State Bar as required by N.C. Gen. Stat. §84-4.1. At that time, Ms. Suda will also file with the Commission a copy of the checks paid as filing fees.
