

SUPPLY OVERVIEW

- On year 3 of 3-year contract with Asset Manager UGI
- We will begin AMA with Gas South on April 1, 2023
- Own 8,613 dth/day of capacity
- Can use up to 20,000 dth/day with UGI contract
- Everything < 8,613 buy at Z3, everything above, buy at Z5
- Historically, we have nominated enough Z3 and Z5 FOM to cover bundled requirements on top of hedges to not be subject to volatile Z5 daily pricing
- Imbalance OFOs and sellback prices from Transco have forced us to modify strategy for nominations
 - Prepare for daily average and use peaking plan to cover remainder

The Low-Income Energy Assistance Program (LIEAP) is a federally-funded program that provides for a one-time vendor payment to help eligible households pay their heating bills.



- Have at least one U.S. citizen or non-citizen who meets the eligibility criteria.
- Meet a monthly income test (see below).
- Have reserves at or below \$2,250.
- Be responsible for its heating costs.
