NOW COMES the Village of Bald Head Island (the “Village”) and moves for leave to file rebuttal testimony and exhibits for Village witness Julie G. Perry in order to allow the witness to adopt the pre-filed rebuttal testimony and exhibits of witness Kevin W. O’Donnell. In support of this Motion, the Village respectfully shows the Commission the following:

1. On February 20, 2023, the Village filed the rebuttal testimony and exhibits of Mr. O’Donnell. One of Mr. O’Donnell’s exhibits was the Affidavit of Julie G. Perry.
2. On February 28, 2023, the Village was informed that Mr. O’Donnell will not be able to attend the expert witness hearing beginning on March 6, 2023, due to unexpected medical matters.
3. In light of Mr. O’Donnell’s inability to attend and testify at the expert witness hearing on March 7, 2023, the Village requests to substitute Julie G. Perry as a witness in Mr. O’Donnell’s stead. Ms. Perry has agreed to adopt Mr. O’Donnell’s Rebuttal Testimony, as filed, for purposes of the hearing in this matter and is prepared to answer cross-examination questions on the testimony.

4. Given that Ms. Perry would adopt testimony previously pre-filed in this docket, no party will be prejudiced by this Motion.

5. The Village has contacted counsel for the Applicants, the Public Staff, and intervenors and is authorized to represent that the parties do not object to the relief requested herein.

WHEREFORE, the Village respectfully requests that Ms. Perry be substituted as a witness for Mr. O'Donnell, be allowed to adopt his testimony, and be permitted to testify in his place at the hearing.
