MOTION TO CANCEL PUBLIC WITNESS HEARING

NOW COMES THE PUBLIC STAFF – North Carolina Utilities Commission (Public Staff), by and through its Executive Director, Christopher J. Ayers, and moves the North Carolina Utilities Commission (Commission) to issue an order canceling the September 27, 2023 public witness hearing. In support of this motion, the Public Staff respectfully shows the Commission the following:

- 1. On July 7, 2023, 904 Georgetown Treatment Plant, LLC (Applicant), filed an application with the Commission seeking authority to increase its rates for providing wastewater utility service in Sandpiper Bay Golf and Country Club in Brunswick County, North Carolina. The Applicant provides wastewater utility service to approximately 795 residential customers.
- On July 31, 2023, the Commission issued an Order Establishing General Rate Case and Suspending Rates.

- 3. On August 21, 2023, the Commission issued an Order Scheduling Hearings, Establishing Discovery Guidelines, and Requiring Customer Notice (Scheduling Order) setting this matter for public witness hearing on September 27, 2023. The Notice to Customers states that "This hearing may be canceled if no significant protests are received on or before Wednesday, September 20, 2023."
- 4. The Scheduling Order directed Applicant to provide the Notice to Customers no later than 10 days after the date of the Scheduling Order and submit a signed and notarized certificate of service not later than 20 days after the date of the Scheduling Order.
- 5. On August 29, 2023, Applicant filed a Certificate of Service stating the Notice to Customers was mailed or hand delivered as specified in the Scheduling Order.
- 6. Presently, one consumer statement has been filed in connection with this matter. It identified concerns with the rate proposed.
- 7. As of the filing of this motion, the Public Staff is unaware of any other customer protests or comments made in connection with this matter. Further, Applicant has represented to the Public Staff that it has not received any other significant customer protests or comments made in connection with this matter.
- 8. The Public Staff has reviewed the filed consumer statement of position. The Public Staff believes neither the quantity nor content of the filed consumer statement of position constitutes the "significant protests" necessary to

avoid the cancellation provision set forth in the Scheduling Order. Regarding the issue set forth in the consumer statement of position, it is well explained and can be considered on the merits by the Commission.

- 9. The Public Staff has contacted counsel for the other party in this docket. The Public Staff is authorized to represent that Applicant supports this motion.
- A proposed order canceling the public witness hearing and directing
 Applicant to notify customers of the cancelation is attached.

WHEREFORE, the Public Staff respectfully requests:

- 1. That the Commission cancel the public witness hearing scheduled for September 27, 2023;
- 2. That 904 Georgetown Treatment Plant, LLC be directed to notify customers that the public witness hearing has been canceled and file proof of the giving of such notice; and
- 3. For such other and further relief as the Commission may deem just and proper.

ORDER CANCELING PUBLIC WITNESS HEARING AND REQUIRING CUSTOMER NOTICE

BY THE CHAIR: On July 7, 2023, 904 Georgetown Treatment Plant, LLC (Applicant) filed an application with the Commission seeking authority to increase its rates for providing wastewater utility service in Sandpiper Bay Golf and Country Club in Brunswick County, North Carolina.

On July 31, 2023, the Commission issued an Order Establishing General Rate Case and Suspending Rates.

On August 21, 2023, the Commission issued an Order Scheduling Hearings, Establishing Discovery Guidelines, and Requiring Customer Notice that, among other things, scheduled a public witness hearing to be held Wednesday, September 27, 2023, at 7:00 p.m., at the Brunswick County Courthouse, Courtroom 2, 310 Government Center Drive NE, Bolivia, North Carolina 28422. The public witness hearing was scheduled for the sole purpose of receiving testimony from the wastewater utility customers. Applicant currently serves approximately 795 residential customers in Sandpiper Bay Golf and Country Club.

The August 21, 2023 Order stated that the public witness hearing was subject to cancellation if no significant protests were received from customers by the deadline stated in the customer notice.

On September 22, 2023, the Public Staff filed a motion requesting that the public witness hearing scheduled for September 27, 2023, be canceled. In support of its motion, the Public Staff states that it has reviewed one consumer statement of position that had been filed in this proceeding and that the consumer identified a concern regarding the rates proposed by Applicant. The Public Staff further states that the issue set forth in the consumer statement of position is well explained. The Public Staff notes that neither the Public Staff nor Applicant have received any other customer protests made in connection with this proceeding. Finally, the Public Staff considers that neither the quantity nor content of the filed consumer statement of position constitutes the "significant protests" necessary to avoid the cancellation provision set forth in the Commission's August 21, 2023 Order. The Public Staff represents in its motion that Applicant does not object to canceling the public witness hearing.

Based upon the foregoing, the Chair finds that the public witness hearing scheduled for 7:00 p.m., on September 27, 2023, in Bolivia, North Carolina should be canceled and notice to customers of the cancellation should be required.

IT IS, THEREFORE, ORDERED as follows:

1. That the public witness hearing previously scheduled for 7:00 p.m., on Wednesday, September 27, 2023, at the Brunswick County Courthouse,

Courtroom 2, 310 Government Center Drive NE, Bolivia, North Carolina is hereby canceled;

2. That a copy of this Order should be mailed with sufficient postage or hand delivered by 904 Georgetown Treatment Plant, LLC to all affected customers no later than September 25, 2023, and that 904 Georgetown Treatment Plant, LLC shall submit to the Commission the attached Certificate of Service, properly signed and notarized, no later than September 26, 2023.
