BY THE COMMISSION: The Commission entered an order on September 28, 2020 scheduling an expert witness hearing to be held in this matter on November 18, 2020. At this hearing, Chair Mitchell ruled that proposed order and/or briefs were to be filed no later than 30 days after notice of the transcript. An order was entered on December 11, 2020 requiring proposed orders and/or briefs be filed no later than January 11, 2020.

On January 11, 2021, the Public Staff filed a Motion for Extension of Time. This motion requested a one week extension, until January 19, 2021, to file proposed orders and/or briefs.
