NOW COMES Carolinas Clean Energy Business Association (“CCEBA”), Intervenor in this Docket, and moves the Commission pursuant to NCUC Rule R1-7(a)(5) for a two-week extension of time to comply with the Commission’s September 20, 2021 Order requesting that parties file comments in response to the Public Staff’s Petition to Revise Commission Rules R8-63 and R8-64. In support of this Motion, CCEBA shows the Commission that:

1. The Commission’s September 20, 2021 Order denying Motion to Stay set October 19, 2021 as the date for all interested parties to file comments in response to the Petition filed by the Public Staff. The Order further set November 16, 2021 as the date by which all parties shall file Reply Comments.
2. CCEBA, through undersigned counsel, is currently an intervenor in an avoided cost proceeding before the South Carolina Public Service Commission, a proceeding which has taken substantial effort and time over the last several weeks. Counsel is actively participating in hearings at this time and has been instructed to hold dates through Tuesday October 19, 2021, open for further hearings.
3. A two-week extension of time would provide undersigned counsel with an opportunity to consult with members of CCEBA and prepare more fulsome and helpful comments in response to the Public Staff’s petition.

4. Undersigned counsel has consulted with counsel for the Public Staff and counsel for the North Carolina Sustainable Energy Association (“NCSEA”), also an intervenor in this docket, and both have consented to this Motion for a two-week extension. Counsel for the Public Staff also requested an equal extension to the Reply Comment deadline, a request to which CCEBA and NCSEA consent.

5. CCEBA does not seek this extension for purposes of delay or any other improper purpose.

WHEREFORE, CCEBA respectfully requests that the Commission extend the deadline for filing comments from October 19, 2021 until November 2, 2021, and the deadline for filing reply comments from November 16, 2021 until November 30, 2021.
